The selection against advertised vacancies in above post code was processed by the Board] and result was declared vide result notices dated 06.10.09.,21.12.2009,26.05.2010,7.6.2010,01.09.2010,27.10.2010,10.2.2011,25.5.2011,26.6.2011 and 02.01.2012 as per merit drawn on the basis of Part-II examination (Descriptive) held on 15.02.2009. The vacancies had been advertised by the Board as per requisitions of Municipal Corporation of Delhi vide advertisement No. 02/2008 with closing date of receipt of application as 12.08.2008.

The selection of the above 02(two) candidates under UR category shall further be subject to fulfillment of all eligibility conditions as prescribed by the statutory RRs & terms and conditions of advertisement as indicated in the advertisement inviting applications and direction of Ld. CAT and the direction of Hon'ble High Court in WP(C) 1641/11 and also subject to thorough verification of their identity with reference to their photographs, signatures, handwriting etc. on the application forms, admission card, etc. by the User Department. The candidature of the candidate is liable to be cancelled by the user Department also, in case the candidate is not found fulfilling the eligibility conditions or any other genuine reasons. The competent authority of the user Department shall arrange to verify the correctness of information/documents as furnished in the application form after verification of the same from original documents/issuing authority. **Further, in particular, the user department i.e. MCD will ensure the eligibility with regard to age relaxation to be allowed to each candidate as per the service rendered as contractual teacher as on 12.08.2008 as per direction of Hon'ble High Court in Para 13&14 of the order in WP(C)1641/2011 titled DSSSBVs Preeti Rathi before offer of appointments.** Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.

The selection/appointment of above mentioned candidate shall further be subject to outcome of any court cases filed by any of the candidates whose candidature has been cancelled.
