## RESULT NOTICE/CANCELLATION ORDER N0.186 GRADE-IV (DASS)(POST CODE NO. 63/2007 AND 38/2008) SERVICES DEPARTMENT, GOVERNMENT OF N.C.T. OF DELHI

DSSSB, as per merit of combined Part II (Descriptive) Examination held on 11.04.09, 12.04.09 and 19.04.09 and consequent upon qualifying Typewriting Speed Skill Test conducted w.e.f. 29 to 31 Dec.2009 and 31.01.2010 by the candidates, had declared result of above post code nominating candidates to Services Department, Govt. of N.C.T. of Delhi for appointment to the post of Grade-IV(DASS). in the Pay Scale of Rs.3050-4590 (Pre-revised) vide result notice No.83 dated 10.03.2010, No. 115 dated 4.10.2010, No. 116 dated 07.10.10, No. 119 dated 15.10.2010 and No.132 dated 31.12.2010. The vacancies had been advertised by the Board as per requisition of Services Department vide advertisement No. 02/2008 with closing date of receipt of application as 12.08.2008.

The Result in respect of Shri Arvind Kumar, Roll No. 02335540 was declared vide Result Notice No. 83 dated 10.03.2010 under PH Category. The dossier of the candidate could not be sent to the user department due to non-availability of application form of Post Code – 038/2008 as the same was not traceable in the Board. Accordingly, Shri Arvind Kumar was called in the Board for recasting of his dossier, however, the candidate Shri Arvind Kumar failed to report to the Board, in response to the Board's Notice. Keeping in view of this, it seems that the Shri Arvind Kumar is no longer interested in the appointment against the post of Grade-IV (DASS), as such his candidature is hereby cancelled.
