RESULT NOTICE (Part-II) STAFF NURSE (POST CODE-22/13)

In continuation of Result Notice (Part-I) vide office order No. 350 dated 30.12.2014 on the basis of written examination held on 09/06/2013 and eligibility regarding educational qualification, age etc. as per Advertisement No. 01/13 and RRs for the post of Staff Nurse (Post Code No. 22/13) the following candidates are provisionally selected and recommended for appointment to the post of Staff Nurse (Post code 22/13) in NDMC. The verification & collection of documents were carried out by the staff deployed from the H&FW Deptt and thereafter the collection of documents were carried out by the staff of DSSSB at Board's office on 22/05/2014, 23/05/2014, 02.09.2014, 22.09.2014 & 23.09.2014 for the pending, absentee, OBC(D), EXSM, OH(OL) candidates etc.

As per decision of Board based on the clarification received from the Services Department, GNCTD all such candidates whose result was withheld for the reason that they belong to SC/ST (outsider) category are eligible for reservation to the post, which are reserved for SC/ST candidate. Therefore, their result is being declared as per the current policy on reservation dated 10/05/2013 based upon case of Deepak Kumar (WPC No. 5390/2010). They are provisionally selected subject to fulfilment of all other conditions as described in RRs provided by the User Department as on cut-off date.

At this stage, the result of those candidates who come in the merit and fulfil all the eligibility criteria for the provisional selection, are hereby declared. Pending result of the remaining candidate & waiting list will be declared later on for all post codes of Staff Nurse.

POST CODE 22/13: The Board is declaring the Part-II result for the Post code 22/13 of 07 candidates (SC-03 & ST-04). On the basis of eligibility criteria and other terms & conditions of RRs of the User Department, i.e. NDMC, (As per requisition of User Deptt. i.e. NDMC, there is no vacancy for UR category in Post Code 22/13) the following candidates are hereby provisionally selected:-

The provisional selection of the above 07 Candidates (SC-3, ST-4) shall further be subject to fulfilment of all the eligibility conditions as prescribed by the statutory RRs and terms and conditions of advertisement as indicated in the advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/ handwriting etc. on the application form, admission certificate etc. The User Department shall also check the claims of age relaxations on account of experience and verify the certificates produced by them. If any, essential qualification is not as per the provisions of the RRs, the candidature of the candidates are liable to be cancelled by the User Department. The Competent Authority of the department concerned shall issue the appointment letter to the candidate after satisfying themselves of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information/documents/caste certificate furnished in the application forms. Further, the recognition of the universities/institutes from where the degrees/diplomas/certificates have been submitted by the candidates should also be verified by the User Department. Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.

Note:

- 1. All the candidates to please note that the final merit list/waiting list will be prepared and notified after declaring full and final result for all eligible candidates.
- There is no post sponsored by the USER department i.e. NDMC in UR category hence no candidate who comes in the zone of consideration is provisionally recommended/selected.
- 3. Final cut-off marks of provisionally selected candidates under post code 20/13 (Staff Nurse) out of total 198 marks are as under:-
