## RESULT NOTICE ASSISTANT PROGRAMMER POST CODE – 032/08 DEPARTMENT OF INFORMATION TECHNOLOGY

This is in pursuance to the directions of the Ld. CAT vide Order dated 28-07-2010 in OA No.933/2010 titled as Nitin Kumar Gupta Vs. GNCTD & Ors. The Ld. CAT in concluding paragraph 6 of its order in OA No.933/10 dated 28-07-2010 has directed that:-

"6. OA stands disposed of with a direction to the respondents to get the fact of applicant having qualified the MCA before the cut-off date verified from the above two Universities and on the basis of a report, claim of the applicant for appointment shall be processed within a period of three months from the date of receipt of a copy of this order. No costs."

The brief facts of the present case are that the applicant i.e. Sh. Nitin Kumar Gupta, Roll No. 3210767 had appeared in the examination for the post of Asstt. Programmer, Post Code 032/08, in Deptt. of Information and Technology held on 22-03-2009. He secured 135/200 marks in the examination. He had got more marks than the last selected candidate under the UR category and was covered under the zone of consideration in UR category. However, the candidature of the applicant was rejected vide Office Order No. 127 dated 10-02-2010. The cut-off date of the advertisement no. 02/08 containing post code 032/08 was 12-08-2008.

As per directions of the Ld. CAT in this case, the Board wrote letters to the two Universities i.e. (1) Registrar, Gautam Buddh Technical University (Formerly U.P. Technical University) and (2) Registrar, Krishna Institute of Engineering & Technology requesting them to intimate after verification whether Sh. Nitin Kumar Gupta had qualified the MCA examination before 12-08-2008 or otherwise. As per report received from both the Universities, the applicant/candidate i.e. Sh. Nitin Kumar Gupta qualified the MCA degree on 20-06-2008 i.e. before the cut-off-date(12-08-2008).

Therefore, in compliance of the Ld. CAT's Order dated 28-07-2010 in OA No.933/2010 titled as Nitin Kumar Gupta Vs. GNCTD & Ors. the applicant /candidate i.e. Sh. Nitin Kumar Gupta is hereby provisionally selected and recommended for appointment to the post of Asstt. Programmer, Post Code-032/08 in Deptt. of Information Technology in the pay scale of Rs. 5500-9000 (Pre-revised).

The Competent Authority of the department concerned shall issue the appointment letter to the candidate after satisfying themselves of his eligibility as laid down in the recruitment rules and on verification of the correctness of the information/documents as furnished in the application form. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The result has been processed keeping in view the eligibility conditions regarding educational qualification/caste certificate as on cut off date i.e. 12-08-2008.
