## RESULT NOTICE NO.185 LDC (POST CODE NO 23/2008) MUNICIPAL CORPORATION OF DELHI

DSSSB, as per merit of combined Part II (Descriptive) Examination held on 11.04.09, 12.04.09 and 19.04.09 and consequent upon qualifying Typewriting Skill Test conducted w.e.f. 29 to 31 Dec.2009 and 31.01.2010 by the candidates, had declared result of above post code nominating candidates to Municipal Corporation of Delhi for appointment to the post of L.D.C. in the Pay Scale of Rs.3050-4590 (Pre-revised) vide result notice No.84 dated 10.03.2010,114 dated 4.10.2010, 117 dated 07.10.10, 131 dated 31.12.10 and 150 dated 21.9.2011. The vacancies had been advertised by the Board as per requisition of MCD vide advertisement No. 02/2008 with closing date of receipt of application as 12.08.2008.

Result in respect of Ms. Neetu had been indicated in pending list for want of SC Certificate which was not found enclosed with her application form. Later on Ms Neetu has submitted the Caste Certificate which was issued to her in lieu of old caste certificate which was lost as per copy of FIR supplied by her. Executive Magistrate (Seelampur) vide their letter dated 03.03.2011 has verified the Caste Certificate as of Delhi Origin however no information about her old caste certificate was furnished. On completion of the verification, result of the Ms. Neetu is finalized and the candidate is provisionally selected for appointment to the post of L.D.C. in Municipal Corporation of Delhi in the Pay Scale of Rs.3050-4590(Pre-revised) under post code 23/08 as per particulars below:

Mere inclusion of the name in the result notice does not confer any right upon the candidate over the post.
