The selection of above mentioned 06 candidates (UR-01, OBC-02, SC-03) shall further be subject to fulfillment of all the eligibility conditions as prescribed by the statutory RR's and terms and conditions of advertisement as indicated in the advertisement inviting applications and also subject to thorough verification of their identity with reference to their photographs, signature/handwriting and thumb impression etc. on the application form, admission certificates etc. The candidature of the candidates is liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the eligibility conditions or due to any other genuine reason.

The **Competent Authority of the department concerned** shall issue the appointment letters to the candidates **only** after satisfying itself of their eligibility as laid down in the recruitment rules especially the recognition of University/Institute, subjects in degree/diploma etc. and on verification of the correctness of the information/documents as regards age, qualifications, caste certificate etc. as furnished in the application form. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

The result has been processed keeping in view the eligibility conditions regarding educational qualification/caste certificate as on cut off date i.e. 02-12-2009..

For admissibility of benefit of reservation the result has been processed as per the judgment of Hon'ble Supreme Court of India dated 04.08.2009 as passed in Civil Appeal No. 5092 of 2009 arising out of Petition (s) for Special Leave to Appeal (Civil) No(s). 24327/05 Subhash Chandra & Anr. V/s DSSSB & Ors.

In case of SC/OBC candidates, the user department shall also get the caste certificates verified from the issuing authority before their appointment. Further, in case of OBC candidates it may be verified that the candidate does not belong to the persons/sections(Creamy layer) mentioned in column 3 of the Schedule to the Govt. of India, Department of Personnel and Training O.M. No. 36012/22/93-Estt.(SCT) dated 08-09-1993, O.M.No. 36033/3/2004-Estt(Res) dated 09-03-2004 and O.M.No.36033/3/2004-Estt(Res) dated 14-10-2008.
