1. In compliance of Ld. CAT order dated 10.01.2014 in C.P. No. 373/2016 in OA No. 1192/2013 in the matter of Suman Rani Vs DSSSB & Ors. and after preliminary scrutiny of the candidature as per the provisions of the statutory Recruitment Rules of the post as well as terms and conditions of the advertisement of these posts as notified, the following candidate is provisionally selected to the post of PGT (Sanskrit) in Directorate of Education, Govt. of NCT of Delhi under post code 34/10 in the pay scale of Rs 9300-34800 having Grade Pay of Rs 4800/- (Non-Gazetted)

The DSSSB vide its advertisement No. 02/2010 with closing date 30.07.2010, had advertised **19 vacancies (UR-10, OBC-06 & SC-03)** for the post of Post Graduate Teacher (Sanskrit) -Female in Directorate of Education under post code 34/10. The examination to the post code was held on 10.12.2011 and the result for Part-I (Objective type examination) of the post was declared on 03.02.2012. As per the merit, drawn on the basis of Part-II descriptive main examination, the final result for the post code 34/10 was declared vide result notice no. 75 dated 22.08.2012.
3. The selection of the above **01 (one)** candidate under SC category shall be further subject to thorough verification of the candidature by the User Deptt. The candidature of the candidate is liable to be cancelled by the user department, in case candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or any other genuine reason(s). The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.
4. The User Department shall also check the eligibility/admissibility of the reservation benefit, if any. Further, wherever applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate. The Competent authority of the user Department shall arrange to verify the correctness of information/documents as furnished in the application form vis-à-vis the original documents. Further, the appointing authority shall also verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidates.
5. Mere inclusion of name of the candidate in the Result Notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
6. Further, the above selection is further subject to outcome of the SLP No 036324/2017 Diary No (S) 36581/2017 in the matter of Govt. of NCT of Delhi Vs. Sushila Devi (with I.A. No 132361/2017).

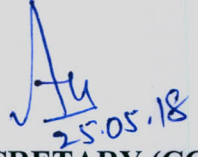

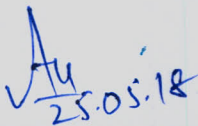
