- 1. The DSSSB vide its advertisement no. 03/2021 dated 27/05/2021 with closing date 03/07/2021 and subsequent corrigendum dated 08/06/2021 and notice to the advertisement no. 03/2021 dated 02/07/2021 had advertised 1029 vacancies (EWS-48, UR-483, OBC-277, SC-69, ST-152 including PwD/OH-22 and PwD/VH-19) for the Post of TGT English-Male under post code 50/21 in Directorate of Education.
- 2. The written examination (online mode in single shift) Tier-I (Technical) for recruitment in respect of this post was conducted on 13/09/2021. Board had released marks of Tier I written examination of the Candidates vide notice number 1330 dated 22/12/2021 and e-dossiers were called from shortlisted candidates as per details mentioned in the said notice.
- 3. Whereas all candidates were instructed vide clause 5 (ii) of the said advertisement that the educational qualification, age, experience, and other eligibility conditions against the post shall be determined as on the closing date of online submission of application.
- 4. Whereas all candidates were informed vide clause 6 (ii) of the said advertisement that Candidates who wished to be considered against reserved vacancies and/or to seek age relaxation, must be in possession of relevant certificates (SC/ST/OBC/Non Creamy layer/PH/Educational/Experience, etc.) issued by the competent/notified authority(in prescribed format) on or before the cutoff date (closing date of advertisement) otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise.
- 5. Now, on scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidates bearing following Roll No. in respect of the above mentioned post code has been found 'Not Eligible' in terms of the advertisement no. 03/2021 with closing date 10/07/2021 and Recruitment Rules for the post of TGT English-Male under post code 50/21 in Directorate of Education Govt. of NCT of Delhi. The candidature of the candidate is therefore, stands rejected:-


