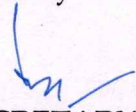

1. The DSSSB vide its advertisement no. 02/2012 with closing date 15/06/2012 had advertised 21 vacancies (UR-12, OBC-06, SC-03) for the Post of Assistant Community Organizer under post code 37/12 in MCD. The Board had conducted Tier-I (T) written examination on 12/10/2019 (offline).
2. On scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidates bearing following Roll Nos. in respect of the above mentioned post code have been found to be 'Not Eligible' in terms of the advertisement no. 02/2012 and Recruitment Rules for the post of Assistant Community Organizer under post code 37/12 in MCD. The candidature of these candidates, therefore, stands rejected:-

i	4050000021	UR	As per documents uploaded by candidate in e-dossier, date of birth of candidate is mentioned as 02.06.1985, whereas, as per advertisement for the said post code, closing date of application was 15.06.2012 and age of candidate under UR Category shall be between 18-27 years. Hence, candidate was overage at the time closing date of application for the said post code.
ii	4050000041	UR	As per documents uploaded by candidate in e-dossier, the marks sheet of 3 rd Semester of degree of Master (Psychology) shows examination was held in the month of October, 2012 i.e. after closing date of application 15.06.2012. Hence, candidate has not possessed requisite Master Degree on the closing date of application.
iii	4050000095	SC	As per documents uploaded by candidate in e-dossier, candidate has done Master Degree in Sociology from IGNOU in the year 2015 after closing date of application i.e. 15.06.2012. Hence, candidate has not possessed requisite Master Degree as per RRs of this post on the closing date of application.

iv	4050000074	SC	As per documents uploaded by candidate in e-dossier, date of birth candidate is mentioned as 10.04.1980, whereas, as per advertisement for the said post code, closing date of application was 15.06.2012 and age of candidate under SC Category shall be upto 32 years. Hence, candidate was overage at the time of closing date of application for the said post code.
