REJECTION NOTICE NO. 1108 DRAFTSMAN GRADE I (CIVIL) IN MUNICIPAL CORPORATIONS OF DELHI UNDER POST CODE 09/12

- 1. The DSSSB vide its advertisement no. 02/2012 with closing date 15/06/2012 had advertised 13 vacancies (UR-09, OBC-03 & SC- 01) for the Post of Draftsman Grade-I (Civil) under post code 09/12 in Municipal Corporations of Delhi. Later on the vacancies for the post of Draftsman Grade-I (Civil) have been reduced to 02 (UR-02) by the MCD. Accordingly, Board vide corrigendum dated 09.04.2013 to the Advertisement No. 02/2012 has modified the vacancies for the post of Draftsman Grade-I (Civil) to 02 (UR-02) from 13. The Board had conducted Tier-I (T) written examination on 21/05/2017 (offline).
- 2. The marks obtained by 43 candidates who have duly appeared in the online examination held on 21/05/2017 have been declared vide Notice No. 664 dated 08.06.2018 and e-dossiers were called between 12.06.2018 to 26.06.2018.
- 3. The candidature of candidate having Roll No. 14000078 was kept pending vide Result Notice No. 1029 dated 06.08.2020 due to deficient document and candidate was given opportunities to upload deficient document vide Notice No. 1099 dated 13.01.2021 (1st recall) and 1105 dated 18.02.2021(2nd recall).
- 4. On scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidate bearing following Roll No. in respect of the above mentioned post code has been found to be 'Not Eligible' in terms of the advertisement no. 02/2012 and Recruitment Rules for the post of Draftsman Grade-I (Civil) under post code 09/12 in Municipal Corporations of Delhi. The candidature of the candidate, therefore, stands rejected:

No. 14000078	UR	The candidate has not submitted the requisite documents i.e. requisite experience as per RRs. in spite of giving 02 opportunity i.e. 15/01/2021 to 24/01/2021 (1st recall) and 09/02/2021 to 13/02/2021 (2nd and final opportunity).
