SUPPLEMENTARY RESULT NOTICE NO. 1109 DRAFTSMAN GRADE I (CIVIL) IN MUNICIPAL CORPORATIONS OF DELHI UNDER POST CODE 09/12

- 1. The DSSSB vide its advertisement no. 02/2012 with closing date 15/06/2012 had advertised 13 vacancies (UR-09, OBC-03 & SC-01) for the Post of Draftsman Grade-I (Civil) under post code 09/12 in Municipal Corporations of Delhi. Later on the vacancies for the post of Draftsman Grade-I (Civil) have been reduced to 02 (UR-02) by the MCD. Accordingly, Board vide corrigendum dated 09.04.2013 to the Advertisement No. 02/2012 has modified the vacancies for the post of Draftsman Grade-I (Civil) to 02 (UR-02) from 13. The Board had conducted Tier-I (T) written examination on 21/05/2017 (offline).
- 2. The marks obtained by 43 candidates who have duly appeared in the online examination held on 21/05/2017 have been declared vide Notice No. 664 dated 08.06.2018 and e-dossiers were called between 12.06.2018 to 26.06.2018.
- 3. Ideally RRs for a post should be revised once in 05 years. RRs for the post of Draftsman Grade-I (Civil) under post code 09/12 was notified on 31.10.1979 by Corporations of Delhi, since than nomenclature Courses/educational qualifications have been changed, accordingly, letters dated 17.07.2018 and reminders dated 26.12.2018 & 21.01.2019 were issued to the User Department mentioning the educational qualifications submitted by the shortlisted candidates for clarifications whether the qualifications meets the requirement of RRs of the post or not. But no such clarifications has been received, hence vide Result Notice No. 1029 dated 06.08.2020 provisionally selected 01 candidate (UR-01) on the basis of merit of the written examination conducted by DSSSB with the advice to the User Department to ascertain the scrutiny of educational qualification and requisite experience as per RRs of the said post, at their own level before issuing the offer of appointment to the proposed candidate. Further, DSSSB has not undertaken the veracity/scrutiny of the essential educational qualifications and experience furnished by candidates.
- 4. The candidature of candidate having Roll No. 14000078 was kept pending vide Result Notice No. 1029 dated 06.08.2020 due to deficient document i.e. requisite experience as per RRs. Further candidate was given two opportunities to upload deficient document vide Notice No. 1099 dated 13.01.2021 (1st recall) and 1105 dated 18.02.2021(2nd recall). Since candidate has not uploaded requisite documents in spite of giving two opportunities, accordingly the candidature of candidate was rejected vide Rejection Notice No. 1108 dated 24/02/2021.
- 5. Consequent upon cancellation of candidature of candidate having Roll NO. 14000078 and on the basis of marks secured in written Examination Tier-I (T) held on 21/05/2017 and after preliminary scrutiny, following candidate is provisionally

selected for the post of **Draftsman Grade-I** (**Civil**) under post code 09/12 in Municipal Corporations of Delhi as per their merit, subject to their fulfilling all others conditions of eligibility and also correctness of information furnished by the candidate in their online application form and e-dossier. Further, user department is being advice to ascertain the scrutiny of educational qualification and requisite experience as per RRs of the said post, at their own level before issuing the offer of appointment to the proposed candidate. Further, DSSSB has not undertaken the veracity/scrutiny of the essential educational qualifications and experience furnished by candidates.

- 6. The selection of the above 01 candidates (UR-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 7. The Selection of the above 01 candidates (UR-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough with reference of their identity to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 8. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Municipal Corporation of Delhi shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in

the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.

- 10. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 11. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 12. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 13. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 14. The category wise marks scored by the last candidate provisionally nominated are as under:-
