Cell/ DSSSB/2019-20/2871-79 dated 24.09.2021, the Board had shortlisted qualified candidates for uploading of e-dossier for the post of Assistant Teacher (Nursery), Post Code-16/19. - Now, as the vacancies have been created due to return of dossiers by the User Department i.e. Directorate of Education within the expiry of waiting panel, more qualified candidates below the merit of last selected candidates who obtained marks above or equal to minimum qualifying marks in their respective categories are shortlisted to upload e-dossiers subject to attaining minimum qualifying marks and correctness of the information furnished by the candidate in their online application forms based on the performance in the examination (online mode) held on 19.11.2019.
- 3. The cutoff marks for uploading of e-dossier only is given as under:-

Note:- Minimum marks for uploading of e-dossier for OBC, SC & VH category remain same as per earlier notice dated 22.06.2020.

- The shortlisted candidates for the above mentioned post code are hereby informed to fill the e-dossier and upload all the documents of Educational/Professional Certificates/Degree and Mark sheets/Caste Certificate/Disability certificate/Proof of Govt. Servant/Ex. Servicemen/Admit Cards etc., as applicable in the E-dossier module in OARS link in his individual account in OARS module. Short listing is being made on the basis of marks obtained in Tier-I written examination (Objective-MCQ) for 200 marks.
- Kindly note that the e-dossier link will be activated to only for new 104 qualified candidates (lower in merit) who are in the consideration zone of selection and were not given any opportunity earlier for uploading of e-dossier.

- 5. The candidate who has been shortlisted for falling in the consideration zone of selection MUST upload his/her all requisite / applicable documents in the said link in stipulated time.
- 6. The e-dossier link shall be activated for a period of 15 days w.e.f. 06/05/2022 to 20/05/2022.
- 7. The candidate uploading e-dossier should ensure that he/she fulfills all the eligibility criteria as on the cutoff date, i.e 15.10.2019 as per Advertisement No. 03/2019. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number & e-mail id. (as an additional facility). If, the candidate fails to upload the e-dossier during the above said period, his/her candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever ground.
- 8. Mere asking the candidate for uploading documents in the e-dossier module does not confer him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his/her documents on or before the date as mentioned above he/she will not be given any further opportunity and his/her candidature will be treated as cancelled.
