1	111503500052	The candidate had uploaded B.Sc. (Physics) alongwith 27 blank white pages in the e-dossier. Therefore, he was given two opportunities w.e.f. 08.12.2021 to 17.12.2021 & 23.12.2021 to 27.12.2021 to upload M.A. (Psychology) & its mark sheet with PG diploma in guidance and counseling. but he failed to upload the above mentioned documents in the e-dossier even after giving two sufficient opportunities. Hence, his candidature is rejected for not having requisite qualification as per RRs.
2	121103500051	The candidate has done M.A. (Psychology) in December, 2020 which is after cutoff date. He was given two opportunities w.e.f. 08.12.2021 to 17.12.2021 & 23.12.2021 to 27.12.2021 to upload M.A. (Psychology) as on cutoff date. But he failed to upload the requisite documents in the e-dossier.

S. no.	Roll No	Reason/Remarks
1	121103500040	The candidate had uploaded M.Sc. (Applied Psychology) after cutoff date. He was given two opportunities w.e.f. 08.12.2021 to 17.12.2021 & 23.12.2021 to 27.12.2021 for uploading of Master degree in Psychology & diploma in guidance and counseling as on cutoff date. However, he has uploaded a representation dated 23.12.2021 in the e-dossier stating that due to global pandemic (COVID-19), the examinations of Diploma in guidance and counseling were conducted in the year 2020 and same also happened in Post Graduation degree. Hence, it is clear that the candidate having degree in Psychology & Diploma in Guidance & counseling after cutoff date and as per policy of the Board, he is not eligible.
