SUPPLEMENTARY RESULT NOTICE NO: 1256 INSTRUCTOR DRAWING, UNDER POST CODE 101/14 IN DIRECTORATE OF TRAINING AND TECHNICAL EDUCATION, GNCTD.

- 1. This is in continuation of Result Notice no. 1045 dated 24.02.2020, Result Notice no. 1197 dated 12.10.2020 and Result Notice no. 1239 dated 12.01.2021.
- 2. The DSSSB, vide its advertisement No. 01/14 had advertised 27 vacancy (UR-11, OBC-08, SC-05,ST & 03 including EXSM- 03 and PH-PH-01) for the post of Instructor Drawing Under Post Code-101/14 in Directorate of Training and Technical Education, GNCTD.
- 3. The marks obtained by 244 candidates, who duly appeared in written examination (Offline mode) held on 24. 09. 2019 were uploaded on Board's website. Further, vide Notice no. 950 dated 18.12.2019, edossiers were w.e.f. 20.12.2019 to 03.01.2020.
- 4. Vide Result Notice No. 1239 dated 12.01.2021 e-dossier link was active w.e.f. 14.01.2021 to 23.01.2021 for uploading the documents, but the candidate could not upload the deficient document within the stipulated time period. Again vide Notice no. 1250 dated 08.02.2021, e-dossier of the candidate was re-called w.e.f. 11.02.2021 to 15.02.2021 for the 2nd time and in response to this notice, the candidate has uploaded the deficient document.
- **5.** The result has been processed keeping in view of the eligibility conditions and relaxation thereof in respect of educational qualifications etc. as on cut-off date i.e. 27.02.2014 for post code-101/14.
- **6.** On scrutiny of the documents uploaded by the candidates, following candidate is found eligible from **waiting panel in OBC** category, as per documents uploaded in support of educational qualification, age etc.
- 7. On the basis of marks secured in the written examination and after preliminary scrutiny, as per the provisions of the statutory Recruitment Rules for the post and the terms and conditions as stipulated in the advertisement, the following candidate is provisionally selected to the post of Instructor Drawing Under Post Code-101/14 in Directorate of Training and Technical Education, GNCTD subject to fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidate in online application form and e-dossier:-

*Note- That as per RRs one of the essential qualification is "1 year/3 years (as applicable) practical experience in the field of concerned trade" Further, the same is a subjective and technical matter and user department has not provided any specification in this regard, therefore, at this stage, DSSSB has not undertaken the veracity/scrutiny of experience certificate furnished by the candidates as such user department i.e. DTTE is requested to ascertain the scrutiny/ correctness of the same at their own level before issuing the offer of appointment to the proposed candidate. The selection is provisional and subject to the satisfaction of user department regarding experience certificate furnished by above candidates.

- 8. The provisional selection of the above One candidate (OBC-01) shall be further subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/ handwriting etc. On the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate. The Competent Authority of the Department concerned shall issue the offer of appointment to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 9. The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The user Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested any minor/clerical error/deficiency rectify/correct, in case, noticed in the documents of the candidate at their own level.



- 10. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidates in the light of Notification No. 36012/22/93-Esttt.(SCT)dated 08/09/1993 issued by DOPT and other instructions/ guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the user department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt, GNCTD after thorough verification of caste certificate.
- 11. User Department shall also get the SC/ST/OBC certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt.(SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14/10/2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 12. The Competent Authority of Department concerned shall issue the appointment letters to the candidates after verification of the correctness of the information furnished in the application form and documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instruction issued in this regard vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 13. The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 14. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 15. The recruitment process for the Instructor Drawing under Post Code-101/14 in Directorate of Training and Technical Education, GNCTD has already been closed subject to disposal of pending cases.
- 16. The Select Panel/Waiting List in respect of UR/OBC/SC Categories for the post of Instructor Drawing Under Post Code-101/14 in Directorate of Training and Technical Education, GNCT of Delhi has been maintained and the same was valid upto 23.02.2021. Further, the Select Panel/Waiting List could not be maintained in respect of ST/PH-OH/EXSM categories as no suitable candidate is available in respective categories.



- 17. The result for the post of Instructor Drawing Under Post Code-101/14 in Directorate of Training and Technical Education, GNCT of Delhi will be subject to outcome of pending court cases, if any.
- **18.** The marks of last provisionally nominated candidates, after this result, is as follows:-
