On scrutiny of marks secured in the written examination and after preliminary scrutiny as per the provision of the statutory Recruitment Rules for the post of EVGC (Female), Post Code-36/20 in Directorate of Education and the terms and conditions of the advertisement, the candidature of 12 candidate in respect of the above said post code is rejected for the reason/ remarks mentioned against her roll number:-

2. UR CATEGORY:-

. 1	111503600013	Diploma in Guidance and Counseling after cutoff date i.e. 09.12.2020. The candidate was appeared in exam of PGDGC in June, 2020 and result was declared on 09.12.2020 which is after cutoff date. The candidate was given two opportunities w.e.f. 06.12.2021 to 15.12.2021 & 22.12.2021 to 26.12.2021 to upload the diploma in guidance & counseling as on cuttoff date i e 13.02.2020 but she failed to upload the same. Hence, rejected.
2	121103600133	The candidate has uploaded PG Diploma dated 11.05.2020 (date of declaration of result) which was after cutoff date. She was given two opportunities w.e.f. 06.12.2021 to 15.12.2021 & 22.12.2021 to 26.12.2021 to upload PG Diploma in Guidance and Counseling as on cutoff date but she failed to upload the same.

The candidate has however, uploaded experience certificate as DCF category from SDMC & KV. 2	121203600024	The candidate had applied OBC (D) but uploaded OBC certificate issued from Uttar Pradesh issued vide no. 664203010159 dated 18.12.2020. The candidate was given two opportunities w.e.f. 06.12.2021 to 15.12.2021 & 22.12.2021 to 26.12.2021. but failed to upload OBC (D) certificate. Her candidature cannot be considered under OBC Ctgy. for being OBC (Outsider), However, her candidature is still alive under UR category but not in consideration zone at present.
3	121203600249	The candidate has done M.A. Psychology in September, 2020 which is after cutoff date. The candidate was given two opportunities w.e.f. 06.12.2021 to 15.12.2021 & 22.12.2021 to 26.12.2021. But he failed to upload the requisite qualification as on cutoff date. i.e. 13.02.2020. Hence, not eligible for having M.A. (Psychology) as on cutoff date.

4	121203600153	Final result of M.A. Psychology is still awaited. & PG diploma in Guidance and counseling December, 2020 which are after cutoff date. The candidate was given two opportunities w.e.f. 06.12.2021 to 15.12.2021 & 22.12.2021 to 26.12.2021. But he failed to upload the requisite qualification as on cutoff date. i.e. 13.02.2020. Hence, not eligible for having M.A. (Psychology) & PG diploma after cutoff date.
5	121103600458	PG diploma in Guidance and counseling December, 2020 which is after cutoff date. The candidate was given two opportunities w.e.f. 06.12.2021 to 15.12.2021 & 22.12.2021 to 26.12.2021. But failed to upload the requisite qualification as on cutoff date. i.e. 13.02.2020. Hence, not eligible for having PG diploma after cutoff date.
6	121203600045	The candidate had applied OBC (D) but uploaded OBC certificate issued on the basis of her father resident of Ghazipur, U.P. issued vide no. 65111305784dated 22.01.2011. The candidate was given two opportunities w.e.f. 06.12.2021 to 15.12.2021 & 22.12.2021 to 26.12.2021. but failed to upload OBC (D) certificate. Her candidature cannot be considered under OBC Ctgy. for being OBC (Outsider), However, her candidature is still alive under UR category but not in consideration zone at present.

She was given two opportunities w.e.f. 06.12.2021 to 15.12.2021 & 22.12.2021 to 26.12.2021 But she failed to upload the same. Hence, rejected for not having Diploma in Guidance & Counseling.
5	121203600361	Diploma in Guidance & Counseling. Diploma in Guidance and Counseling after cutoff date i.e. 29.07.2021. She was given two opportunities w.e.f. 06.12.2021 to 15.12.2021 & 22.12.2021 to 26.12.2021 But she failed to upload the same. Hence, rejected for having Diploma in Guidance & Counseling after cutoff date.
