SUPPLEMENTARY RESULT NOTICE NO. 1357 ASSISTANT SUPERINTENDENT, (POST CODE 38/13) IN PRISON DEPARTMENT, GNCTD

- The DSSSB vide its advertisement number 02/2013 with closing date 02/08/2013, had advertised 35 vacancies (UR-19, OBC-09, SC-05, ST-02, out of which 04 vacancies were reserved from EXSM) for the Post of Assistant Superintendent in Delhi Prisons Department in the pay scale of Rs. 5200-20200 having Grade pay of 2800/- (Group-C Jail cadre).
- 2. That Sh. Pawan (D.O.B. 28.02.1990), Category-SC having Roll No. 13007112 (Written), 3813007112 (PET) applied for the Post Code 38/13 and appeared in Written exam held on 09.03.2014 and obtained 141.5 marks in the written examination.
- 3. Based on marks obtained in written examination candidates including Sh. Pawan were shortlisted for Physical Endurance Test-II vide Notice Number 395 dated 15.06.2016, which was scheduled on 13.07.2016. Sh. Pawan did not appear in the PET scheduled on 13.07.2016. Therefore his candidature was not considered further in the post code 38/13.
- 4. The selection against the advertised vacancies in the abovementioned post code was processed by the Board and results were declared vide Result Notice No. 342 dated 15.10.2015, Result Notice No. 350 dated 18.10.2015, Result Notice No. 367 dated 14.01.2016, Result Notice No. 415 dated 28.07.2016, Result Notice No. 511 dated 16.05.2016, Result Notice No. 679 dated 30.06.2018, Result Notice No. 733 dated 14.11.2018, Result Notice No. 756 dated 07.01.2019, Result Notice No. 1038 26.08.2020 and Corrigendum No. 1044 dated 08.09.2020.
- 5. That Sh. Pawan filed OA No. 4312 of 2016 and the Ld. Central Administrative Tribunal (hereinafter referred as the Tribunal) vide ex-parte interim order date 09.01.2017 directed that one post of Assistant Superintendent of Prison shall be kept reserved for Sh. Pawan. Thereafter, Ld. Tribunal vide impugned order dated 20.01.2021 allowed the OA filed by Sh. Pawan. The DSSSB filed W.P. (C) 6611/2021 & CM NO. 20763-64/2021, GNCT of Delhi Vs Sh. Pawan, but the Hon'ble High Court dismissed the said Writ Petition vide its order dated 16.07.2021.

- 6. Sh. Pawan qualified the Physical Endurance Test conducted on 02.12.2021 by DSSSB, in compliance of Order dated 20.01.2021 of Ld. Tribunal in OA No. 4312 of 2016, which was upheld by Hon'ble High Court of Delhi vide its order dated 16.07.2021 W.P.(C) 6611/2021 & CM NO. 20763-64/2021 titled as GNCT of Delhi Vs Sh. Pawan. The result of PET was declared vide notice no. 1327 dated 10/12/2021.
- 7. In compliance of abovementioned orders of Ld. Central Administrative Tribunal, which was upheld by Hon'ble High Court of Delhi and on the basis of written Examination held on 09/03/2014 and being qualified in PET conducted on 02.12.2021 and having been found provisionally eligible as per documents uploaded in support of Educational Qualification, Age, etc. in accordance with the advertisement no. 02/2013 and RRs for the Post of Assistant Superintendent under post code 38/13 in Delhi Prisons Department, the following Candidate are hereby provisionally nominated as per their merit:-

- 8. The selection of the above said 01 candidate under UR category shall further be subjected to fulfillment of all eligibility conditions as prescribed by the statutory RRs and terms and conditions of advertisement No. 02/13 and also subject to thorough verification of his identity with reference to his photograph, signatures, handwriting etc. on the application forms, admission cards, etc. by the User Department.
- 9. The selection of the above 01 candidate shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. Further, the User Department shall arrange measurement of physical standards, i.e., Height and Chest and also checking of defect or deformity (including bow-legged, Knocked Knees, Flat feet, etc.) of the candidates as per the requirements of the RRs, which has not been done by the DSSSB, before issue of appointment order.
- 10. The Selection of the above 01 candidate shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of his identity with reference to his photograph, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidate is liable to be cancelled by the user department also, in case the candidate is found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to



the candidate after being satisfied about his eligibility as prescribed in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

- 11. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Prison Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 12. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of his category certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 13. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment.
- 14. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 15. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.

- 16. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 17. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 18. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
