SUPPLEMETARY RESULT NOTICE No. 1359 STENOGRAPHER, GRADE-III (POST CODE 21/18) IN SERVICES DEPARTMENT, GNCT OF DELHI

- 1. The DSSSB vide its Advertisement No. 02/18 with closing date 13/08/2018 and subsequent corrigendum dated 19/07/2018, Addendum dated 07/09/2019 and corrigendum to addendum dated 10/12/2019 had advertised 256 vacancies (UR-91, OBC-101, SC-24, ST-40 including OH-05, HH-04, VH-09, Multiple Disability-01, EXSM-17 and SP-06) for the post of STENOGRAPHER, GRADE-III in Services Department, GNCT Of Delhi under Post Code 21/18. Board Conducted Tier-I written examination for recruitment in respect of this post on 04/10/2019 and 10/10/2019.
- 2. On qualifying Written Examination, vide Notice No. 882 dated 23/01/2020, the DSSSB has shortlisted 1947 candidates for appearing in Skill Test/Shorthand Test and Typing Test for the post of Stenographer, Grade-III under Post Code 21/18. The Skill Test was conducted on 9th, 10th, 11th, 12th, 15th, 16th, 17th, 18th, 19th, 22nd, 23rd, 24th, 25th, 26th, February, 2021 and 1st, 2nd, 3rd, 4th, 5th, 8th, 9th, 10th, 12th, 15th, 16th and on 25th (for VH) March, 2021 (Total 26 days) wherein out of 1947 candidates, 1294 candidates appeared for the test. In the Skill Test conducted, out of 1294 candidates only 425 candidates could qualify. The result of skill test was declared vide notice no. 1129 dated 20/04/2021.
- 3. In evaluation of the shorthand skill test answer sheets of candidates, the Board has considered/condoned up to 7% mistakes for UR category candidates and up to 10% mistakes for all reserved category candidates, as qualified with a speed of 80 w.p.m.
- 4. Those reserved category candidates who were shortlisted in UR Category as per clause 7 of notice no. 882 dated 23/01/2020, for appearing in Skill Test, availing relaxation of mistakes/percentage of errors up to 10%, have been be considered in their respective category.
- 5. As per RR of the Post the candidate was to Qualify 40 w.p.m. in Typewriting in English or 35 w.p.m. in Typewriting in Hindi, as well.

- DSSSB vide result notice no.1178 dated 17.06.2021 provisionally selected 207 candidates (UR-73, OBC-85, SC-22, ST-21, EXSM-01, OH-02, VH-01 and Sports-02) for the Post of STENOGRAPHER, GRADE-III under Post Code 21/18 in Services Department.
- 7. The user department i.e. Services Department vide letter dated 26/11/2021, 29/10/2021, 15/12/2021, 28/12/2021, 05/01/2022, 28/01/2022, 04/02/2022 has returned 20 dossiers and 04 resignation orders i.e. total 24 (UR-12, OBC-10, SC-01 and ST-01) of provisionally nominated candidates under Post Code 21/18 on the grounds that selected candidates either did not accepted the offer of appointment/did not responded within the specified period or resigned. The validity of the waitlist panel for the post code 21/18 is upto 16/06/2022 and returned dossiers/candidature cancellation orders/resignation orders have been received prior to expiry of waitlist panel, hence candidates from waitlist panel have been considered for selection against the vacant posts created due to returned dossiers/resignation.
- 8. The candidature of candidate having roll no. **12370104812**, was kept pending vide Result Notice No. 1178 dated 17/06/2021 under Post Code 21/18 for further scrutiny of his OBC (Delhi) certificate. Now, as per report received from the concerned issuing authority, the candidature of candidate has been considered by the Board in OBC Category under post code 21/18.
- 9. The following candidates are hereby provisionally nominated in post code 21/18, as per their merit, according to roll nos. of written examination of the candidates:-

 The User Department, i.e., Services Department is requested to thoroughly examine the sports field and sports person certificates provided by the above candidates from

different associations/federations etc., in the light of para A (IV), (V) and Para H of DoPT O.M. F. No. 14034/01/2013-Estt. (D) Dated 3rd October, 2013 regarding consolidated instructions on incentives for Sports Persons in Government of India before issuance of any appointment letter. If any candidate does not fulfill the eligibility criteria with regard to sports person category his/her e-dossier may be returned after cancellation of his/her candidature at your level.

- 11. The candidature of 01 candidate having roll no. **12360101044** earlier selected in OBC category now shifted to UR category as per their merit in the post code 21/18.
- 12. The candidature of 01 OBC (other state) candidate having roll no. 11180100174 is hereby rejected in post code 21/18, on the grounds that the candidate was shortlisted for skill test as OBC (Delhi) category candidates and had availed benefits of reserved categories candidates and was treated as Qualified in OBC category after considering percentage of error (dictation/shorthand) i.e., upto 10%. The candidate has submitted in her e-dossier, the OBC certificate No. 90500000294773 dated 24/08/2017 vide which she has been declared as SUNAR community of Uttar Pradesh State. It is evident that the candidate is not having OBC (Delhi) certificate issued under Notification No.F.28(93)/91-92/SC/ST/P&S/4384 F.(8)/11/99dated 20.01.1995, 2000/DS/CST/SCP/OBC/2855 dated. 31.05.2000 F.8(6)/2000-01/DSCST/SC/OBC/ 11677 dated 05.02.2004 & 21.11.2017. Since the candidate was not having OBC (Delhi) Certificate on 13/08/2018 in accordance with clause 5 (ii) of advertisement no. 02/18 dated 05/07/2018 her claim for OBC (Delhi) category has not been entertained. Her application has been considered against un-reserved (UR) category vacancies if eligible otherwise. Since, the candidate had already availed benefits of reserved categories candidates, therefore, the candidate having roll no. 11180100174 can not be considered in UR category in post code 21/18.
- 13. The candidature of candidate under PH (VH) category having roll no. 12370104997 was earlier kept pending vide Result Notice No. 1178 dated 17/06/2021 under Post Code 21/18 for further scrutiny of the genuineness of the candidature of the said candidate. Now, The candidature of candidate under PH (VH) category having roll no. 12370104997 is hereby still kept pending in the post code 21/18 for further scrutiny of the genuineness of the candidature of the said candidate.
- 14. The selection of the above 24 candidates (UR-11, OBC-12, SC-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 15. The Selection of the above 24 candidates (UR-11, OBC-12, SC-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the

application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

- 16. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Services Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 17. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 18. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 and 13/05/2017.
- 19. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and

other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.

- 20. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 21. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 22. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 23. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
- 24. The category wise marks scored by the last candidate provisionally nominated are as under:-

25. The recruitment process for the Post of STENOGRAPHER, GRADE-III under Post Code 21/18 has already been closed. Further, the Wait List panel of the candidates shall be valid up to 16/06/2022.
