5. Mere asking the candidate for uploading the deficient documents in the e-dossier module does not confer any right to selection to the applied post. Final selection will be made purely on the basis of

merit against the notified vacancies, provided the candidate falling in the zone of consideration, fulfils all the required eligibility conditions. It is stated that if the candidate fails to upload his deficient documents during the stipulated time, he/she will not be given any further opportunity for uploading the deficient documents on whatsoever ground and his/her candidature will be treated as rejected being ineligible.
