It is further clarified that the eligibility regarding knowledge of Hindi/ working knowledge of Hindi has not been checked by the DSSSB due to late instructions issued in this regard by the User Department and therefore appropriate action in this regard may be taken by the User Department before issuance of appointment letter.

Further, the candidates whose roll No. find place at SI. No. 1 to 13 above stand deleted from the result notice no. 51 dated 01/08/2016 due to shifting of these candidates from Post Code-14/13 to Post Code-116/12 as per their merit. The result of these candidates under the present notice is merely change of their post code as per their merit for correction of record.
