MANAGER (TRAFFIC), POST CODE-25/15 IN DTC

The DSSSB vide its advertisement No. 01/2015 had advertised 18 {UR-11, OBC-04, SC-02, ST-01 vacancies for the post of Manager (Traffic), Post Code-25/15 in DTC with closing date 26.11.2015. Tier-I (Objective type) & Tier-II (subjective type) written examination was held on 03/06/2018.

- 2. On the basis of offline examination of Tier-I & Tier-II held on 03.06.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.01/2015 and RRs for the post of Manager (Traffic), Post Code-25/15 in Delhi Transport Corporation, 08 Candidates (UR-06, OBC-01, SC-01) were provisionally selected for the post of Manager (Traffic), Post Code-25/15 in Delhi Transport Corporation vide Result Notice No. 371 dated 13.03.2020 and the candidature of 02 candidates under UR category was kept pending for want of deficient documents and his documents were recalled w.e.f. 16.03.2019 to 22.03.2019.
- 3. Out of two candidates whose candidature was kept pending for want of deficient documents, only 01 candidate has uploaded the requisite documents during the period 16.03.2019 to 22.03.2019 and found eligible as per RRs.
- 4. Accordingly, in continuation to Result Notice No. 371 dated 13.03.2019, the candidate, as detailed below, is also provisionally selected on the basis of offline examination of Tier-1& Tier-II held on 03/06/2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.01/2015 and RRs for the post of Manager (Traffic), Post Code-25/15 in Delhi Transport Corporation, subject to his fulfilling all other conditions of eligibility and also correctness of the information furnished by the candidate in his online application forms and e-dossier:-

5. * As per RRs one of the essential qualification is "at least 03 years experience of Supervisory duties in a Traffic Department of a State Road Transport Corporation./ undertaking or of some other important road transport concern. As the same is a subjective and technical matter and user department has not provided any specification in this regard, therefore, at this stage, DSSSB has not undertaken the veracity/scrutiny of

experience certificate furnished by the candidate as such user department i.e. Delhi Transport Corporation is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the proposed candidate. The selection is provisional and subject to the satisfaction of user department regarding experience certificate furnished by above candidate.

- 6. The selection of the above 01 candidate shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his identity with reference to his photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate are liable to be cancelled by the User Department also, in case the candidate is found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 7. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the

candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

- 10. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 11. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- **12.** The result process for the above post code stands closed in all respect except 01 pending candidates.
- 13. The candidature of the following 01 (one) candidate has been kept pending due to the reasons mentioned against his roll no.:-

- 14. The above pending 01 candidate i.e. having Roll No. 13700118 is being given 2nd and final opportunity to upload his pending documents as mentioned above through the e-dossier module in stipulated time w.e.f. 20/08/2020 to 24/08/2020, failing which his candidature will be rejected without any further notice.
- 15. The e-dossier link shall be activate from w.e.f. 20/08/2020 to 24/08/2020. If the candidate fails to upload required document through e-dossier during the above said period his candidature will be rejected and no further opportunity for uploading in the e-dossier will be given on whatsoever ground.
- **16.** The waiting panel to the post of Manager (Traffic) Post Code-25/15 has been expired on 12.03.2020 as per earlier result notice no. 371 dated 13.03.2019.
- 17. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
