## NOTICE

The candidature of 01 candidate bearing Roll No. 3530000165 under UR (Male) category for the post of Swimming Life Guard in Directorate of Education under Post Code-205/14 was kept pending for want of 02 years experience certificate in the e-dossier by giving him 1<sup>st</sup> opportunity w.e.f. 20.01.2020 to 29.01.2020.

2. The candidate has uploaded experience certificate but after scrutiny of experience, it was found that he has less than 02 years experience in the line and accordingly his candidature for the post of Swimming Life Guard post code- 205/14 was rejected vide Rejection Notice No. 595 dated 12/02/2020 for not having 02 years experience in the line.

3. The Candidate has submitted representation dated 18/02/2020 in the Board and stated that he could not upload the experience certificate of remaining years due to some technical fault and requested to give him one more chance so that he could upload the experience certificate in the e-dossier.

4. Accordingly, after considering his representation and as per policy of the Board, the Competent Authority has revived his candidature for the post of Swimming Life Guard under Post Code-205/14 and is being given 2<sup>nd</sup> and final opportunity to upload the deficient documents in the e-dossier w.e.f. **21/08/2020 to 25/08/2020**, failing which his candidature will be rejected and no further opportunity will be given on whatsoever ground.

5. Therefore, the candidate bearing Roll No. 3530000165 is hereby directed to upload the deficient / requisite documents in the e-dossier as given below:-
