Board had conducted Tier I examination on 30/11/2014 and Tier II examination on 28/06/2015 for the post of PGT (Economics). Thereafter, the final result was declared vide Result Notice 443 dated 17/10/2016 and has provisionally selected 39 candidates for the post of *Post Graduate Teacher (Economics) (Male)* in Directorate of Education under **Post code 130/2012** in the pay scale of Rs. 9300-34800 having Grade Pay of 4800/- (Non- Gazetted).

Vide Result Notice 443 dated 17/10/2016 one post in UR category has been kept pending in view of representation filed by candidate having Roll No 28001037 (Rakesh Kumar). As per the report of Scrutiny Branch and IT Branch, candidate Sh Rakesh Kumar had applied for the post of PGT (Economics) for post code 130/2012 vide ID No. 2583715. He has obtained 93.25 marks in Tier I Exam. In post code 130/2012, the marks of the last shortlisted UR candidate were 79.25 marks, accordingly his candidature is being considered in Post Code 130/2012.

On the basis of the merit list of Tier- II examination and after determining eligibility for the post as per the provisions of the statutory Recruitment Rules of the post and the terms and conditions of the advertisement, the following candidate is also hereby provisionally selected for the post of *Post Graduate Teacher (Economics) (Male)* in Directorate of Education under **Post code 130/2012:**

The candidature of candidate having roll number 28001977 is still pending in OBC category for want of document.

The selection to the above 01 Candidate shall be further subject to the thorough verification of the candidature of the candidate by the User Department including the identity of the candidate. The candidature of the

candidate is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be the final and binding on the DSSSB and the candidate.

The candidates who have availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination have been considered for final appointment in their respective category only. The User department shall also check the eligibility of the reservation benefit, if any as per the reservation policy of the Government of NCT of Delhi. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application form vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
