furnished in the application forms. Further, the recognition of the Universities from which the degree/diploma/certificates have been submitted by the candidates should also be verified.

Note: - OBC (Outside Delhi) has been treated as UR candidate and also required 60% marks in CTET.

The User department shall also get the SC/ST/OBC certificates verified from the issuing authority before his/her appointment.
