Kind Attention:- The Candidates for the Post of TGT (English) Female, under Post Code-132/17 – regarding.

The DSSSB vide its advertisement No.04/2017 DATED 20/12/2017 had advertised total 311 vacancies (UR-125, OBC-67, SC-57 & ST-62(including PH/OH-04 & PH/VH-05) for the post of TGT (English) Female under Post code-132/17 in Directorate of Education with closing date as 31.01.2018. Tier-I examination in offline computer based examination mode was conducted on 08.09.2018.

On the basis of offline examination of Tier-1 held on 08.09.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of TGT(English), Post Code-132/17 in Directorate of Education, the candidature of the following candidates has been kept pending for want of deficient /requisite documents in the e-dossier and accordingly they are being given 1<sup>st</sup> opportunity to upload the deficient documents in the e-dossier as mentioned against their roll No.:-

1	2660021890	1 <sup>st</sup> page of e-admit card duly signed by the invigilator is required in the e-dossier.
2	2660005029	The candidate has uploaded CTET after cutoff date. Hence, CTET qualified certificate as on cutoff date i.e. 31.01.2018 is required in the e-dossier.
3	2660003624	OBC (Delhi) certificate required in the e-dossier. The candidate has uploaded OBC certificate which is reserved to the post for appointment to the Other Backward Class under Govt. of India whereas OBC (Delhi) certificate gazette notification issued by Govt. of NCT of Delhi required.
4	2660002367	The candidate has not uploaded OBC (Delhi) certificate. Hence, OBC (Delhi) certificate required in the e-dossier.

- 2. The above candidates are being given 1<sup>st</sup> opportunity to upload the deficient documents in the e-dossier w.e.f. 24.02.2021 to 05.03.2021.
- 3. The e-dossier link for the above pending candidates only for uploading of deficient/requisite documents shall be kept open for a period of 10 days w.e.f. 24.02.2021 to 05.03.2021
