- 2. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after satisfying themselves of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age, Physically Handicapped/Caste and other essential Certificates.
- 3. The nomination under UR category & SC category has been carried out with reference to the letter dated 29/06/2018 of the user department i.e. Directorate of Education, GNCTD wherein 42 dossiers (UR-27, OBC-02, SC-09, ST-04) of the candidates have been returned after cancellation of their candidature for not reporting to the user department inspite of giving sufficient opportunities for verification of documents in DOE. Out of 42 vacancies which have been created due to return of dossiers, only 36 vacancies (UR-27, SC-09) have been filled up and 06 vacancies (OBC-02, ST-04) could not be filled up for non-availability of the qualified candidates in the respective category. 01 candidate under ST category whose candidature was kept pending earlier for want of essential documents in the e-dossier has also been nominated after receiving the essential documents in the e-dossier.
- 4. The candidates mentioned at SI. No. 7 & 15 under UR category above have already been nominated under OBC category vide Result Notice no. 190 dated 27.09.2017. Their candidature is now considered under UR category as per their own merit. The user department may make necessary corrections in the record accordingly. Further, 11 vacancies under UR Category & 01 Vacancy under SC category have been kept reserved for court case candidates. These vacancies will be filled up after finalization of the case in the Hon'ble Court.
- 5. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
