## **REJECTION NOTICE NO. 584**

## SPECIAL EDUCATION TEACHER, POST CODE-87/17

## IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 dated 20/12/2017 had advertised total 605 vacancies [UR-175, OBC-258, SC-103 & ST-69] for the post of Special Educator under Post code-15/17 in Directorate of Education with closing date as 31.01.2018. Later on vide addendum dated 14/05/2018, the number of vacancies was increased to 1329 (UR-542, OBC-453, SC-211 & ST-123). Tier-I examination in offline mode was conducted on 29.07.2018.

- On the basis of offline examination of Tier-1 held on 29.07.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of Special Education Teacher, Post Code-87/17 in Directorate of Education a total of 281 (UR-136, OBC-31, SC-76, ST-08, PH/OH-13 & PH/VH-17)) candidates were provisionally nominated for the post of Special Educator vide Result Notice No.360 dated 28.02.2019 and their dossiers were sent to user department for further necessary action.
- Out of these forwarded dossiers, the user department vide letter dated returned the dossiers of two candidates having Roll No. 25/04/2019 2290009055 (UR) and Roll No. 2290000022 (ST) seeking clarification about the discrepancy in their 2<sup>nd</sup> page of admit card as it bears two different roll numbers.
- The matter was examined in the board and it is observed that Roll No. 2290009055 (UR) has used 2<sup>nd</sup> page of the admit card of some other candidate (who was appearing in the same exam under same post code at different centre.) by pasting his own photograph on it and Roll No. 2290000022 (ST-PH(VH) has used her own 2<sup>nd</sup> page of admit card of different post code in which she has also applied.
- The conduct of examination is a sacrosanct activity. In the General 5. Instructions for candidates for the post of Special Education Teacher, held on 29/07/2018 were issued vide Notice no. F.55(1364)/Exam-I/DSSSB/2017/1158 dated 08/07/2018, wherein it was clearly mentioned that:
- "2. No candidate will be allowed to enter the examination centre without admit card consisting of two pages and without any I.D. proof (in original) under any circumstances.

- 3. The candidates are required to bring their recent coloured passport size photograph which is required to be pasted on 1<sup>st</sup> page of Admit Card. Further, candidate is also directed to bring one post card size photograph (4"\*6") upper half displaying only face, both year and both shoulders, which is required to be pasted on the 2<sup>nd</sup> page of Admit Card and the same is to be handed over to the invigilator on the Exam day after signing and affixing thumb impression in the presence of invigilator. Candidate should ensure that the 2<sup>nd</sup> page Admit Card is handed over to the invigilator as otherwise the candidate himself will be responsible for consequences."
- 6. Further the roll no. 2290000022 is a PH/VH candidate and facility of scribe is given to her. The PwD(Blind) candidates do compete with PwD(Blind) candidates only, so no discrimination can be done on this ground with other PwD(Blind) candidates. Thus, it is evident that above said two candidates totally failed to follow the above said instructions issued by the board.
- 7. Now therefore, the candidature of the following **02 candidates** bearing following Roll No. in respect of the above mentioned Post code is rejected for the reason mentioned against their roll no.:-

**UR Category: 01**

1.	2290009055	Failed to bring correct 2 <sup>nd</sup> page of Admit Card and used some other candidate's admit card by pasting his own photo on it to gain entry in the examination hall.

ST Category: 01

S.No.	Roll No.	Reason
1.	2290000022	Failed to bring correct 2 <sup>nd</sup> page of Admit Card and used some other post code's admit card to gain entry in the examination hall.
