## **SUPPLEMENTARY RESULT NOTICE NO.603**

## PGT (HISTORY) MALE, POST CODE-112/17 IN DIRECTORATE OF EDUCATION

The DSSSB vide its advertisement No.04/2017 dated 20/12/2017 had advertised total 92 vacancies [UR-47, OBC-25, SC-12, ST-08 including PH: OH-01, VH-01 PH] for the post of PGT (History) Male under Post code-112/17 in Directorate of Education with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on 05.07.2018.

- On the basis of online examination of Tier-1 held on 05.07.2018 and having been found 2. provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of PGT (History) Male, Post Code-112/17 in Directorate of Education a total of 63 (UR-34, OBC-11, SC-11, ST-07 including 01 UR/PH) candidates were provisionally nominated for the post of PGT (History) Male, Post dated 19.12.2018 and the candidature of 20 Code-112/17 vide Result Notice No.319 candidates were kept pending for want of clarification/documents and their documents were recalled w.e.f. 22.12.2018 to 28.12.2018. These candidates were also informed separately through SMS on the registered Mobile number and the candidature of 09 OBC category candidates were kept pending for verification of their OBC (Delhi) status from the Revenue Authority. Further, 26 candidates (UR-10, OBC-14, SC-01, ST-01 including 02 UR/PH) were nominated and the candidature of 03 candidates under UR category was kept pending vide Supplementary Result Notice No. 482 dated 12/07/2019. Now, the User Department i.e. Directorate of Education vide letter dated 16.12.2019 has returned 05 dossiers (UR-02, SC-02, ST-01 including 01 VH category) of the candidates who did not accept the offer of appointment / no response from the candidates was received even after giving sufficient opportunities by the user department, thereby creating, 05 vacancies in their respective category. As the waiting panel was valid upto 19.12.2019, the eligible candidates from the waiting panel have been taken into consideration for nomination against the vacant posts.
- 3. Therefore, **04 candidates** (**UR-02**, **SC-02 including UR/PH/VH-01**) who have been found eligible on scrutiny of the documents uploaded by the candidates, these candidate are being nominated. The candidature of 01 candidate under ST category has been kept pending for want of deficient documents in the e-dossier.
- 4. (I) Accordingly, in continuation to Result Notice No. 319 dated 19.12.2018, Supplementary Result Notice No. 482 dated 12/07/2019, the candidates, as detailed below, are also provisionally selected on the basis of online examination of Tier-1 held on 05.07.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of PGT (History) Male, Post Code-112/17 in Directorate of Education.

- 5. The selection of the above 04candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 7. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the

- candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
- 10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 11. The result process for the above post code stands closed except 03 vacancies under UR category for the candidates bearing Roll No. 2040012377, 2040011415, 2040010280 due to technical reasons which have been kept pending for want of clarification / deficient document in the e-dossier as referred at para-13 in Supplementary Result Notice No. 482 dated 12.07.2019.
- 12. Further, the candidate bearing roll No. 2040006710 under ST category whose candidature has now been considered from waiting panel is also kept pending for want of (1). M.A. degree, (2). Marks sheet of final year of M.A. degree, (3). B.Ed. degree & (4). Marks sheet of B.Ed. degree are required in the e-dossier. This candidate will be given 1<sup>st</sup> opportunity to upload the deficient documents in the e-dossier in due course of time.
- **13.** The wait list/panel for the post code 112/17 was valid for a period of one year, i.e. upto **18.12.2019** as per earlier result notice no. 319 dated 19.12.2018.
- 14. Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the User department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
