PGT (PHYSICAL EDUCATION TEACHER) MALE, POST CODE-94/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised 86 {UR-44, OBC-23, SC-13, ST-06} for the post of PGT (PHYSICAL EDUCATION TEACHER) (MALE) POST CODE-94/17 in Directorate of Education with closing date as 31.01.2018. Tier-I examination in offline written examination mode was conducted on 12/08/2018.

- On the basis of offline examination of T-I held on 12.08.2018 and having been found 2. provisionally eligible as per documents uploaded in support of educational qualification, age, etc in accordance with advertisement no. 04/2017 and RRs for the post of PGT (Physical Education Teacher) Male. Post Code-94/17 in Directorate of Education a total of 75 (UR-36, OBC-22, SC-12. ST-05) candidates were provisionally nominated for the post of PGT (Physical Education Teacher) Male, Post Code-94/17 vide Result notice No. 403 dated 15.04.2019 and the candidature of 10 candidates were kept pending for want of deficient / requisite documents and 01 candidate was kept for verification of OBC (Delhi) status. These candidates were given 1st opportunity to upload the deficient / requisite documents in the e-dossier w.e.f. 20.04.2019 to Further, a total of 10 candidates (UR-07, OB-01, SC-01, SC-01) were 29.04.2019. provisionally nominated vide Supplementary Result Notice No. 500 dated 04.09.2019 and 01 candidate was kept pending for want of deficient / requisite documents in the e-dossier. He was given 2nd and final opportunity to upload the same w.e.f. 06.09.2019 to 12.09.2019. Thereafter, 01 candidate under UR category has been nominated vide Supplementary Result notice no. 542 dated 15.11.2019.
- 3. Now, the User Department vide letter dated 23.12.2019 has returned the dossiers of two candidates (SC-01, ST-01) after cancellation of their candidature due to not accepting of offer of appointment. Accordingly, 02 vacancies under SC-01 & ST-01 have been vacant. Therefore, the candidature of eligible candidates in waiting panel is being taken into consideration for nomination in their respective category. However, out of these two candidates, one candidate under ST category has been kept pending for want of deficient documents in the e-dossier.
- 4. Accordingly, in continuation of Result Notice No. 403 dated 15.04.2019, Supplementary Result Notice No. 500 dated 04.09.2019 & Supplementary Result Notice No. 542 dated 15.11.2019, the candidate, as detailed below, is provisionally selected on the basis of offline examination of Tier-I held on 12.08.2018 and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc. in accordance with advertisement No. 04/17 and RRs for the post of PGT (Physical Education Teacher), Male, Post Code-94/17 in Directorate of Education:-

- 5. The selection of the above 01 candidate shall further be subject to genuineness of the documents on the basis of which he/she has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of his identity with reference to his photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidate is liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- Further, if applicable, the User Department i.e. Department of Food Safety shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the edossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- It is stated that the User Department shall verify the genuineness of the caste 7. certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed certificate as specified various OBC (Delhi) entitlement of Orders/Guidelines/Circulars including order dated 07/03/2017 issued Revenue Department, GNCTD after thorough verification of caste certificate.
- 8. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 9. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the

- application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.
 - 10. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
 - 11. The recruitment process for the post of PGT (Physical Education Teacher) Male, Post Code-94/17 stand closed except 01 pending case.
 - **12.** The candidature of the following 01 (one) candidate has been kept pending due to the reasons mentioned against his roll no.:-

- 13. The above pending 01 candidate i.e. having Roll No. 2440002791 is being given 1st opportunity to upload the deficient / requisite documents as mentioned above through the edossier module w.e.f 28/02/2020 to 08/03/2020, failing which his candidature will be rejected without any further notice.
- 14. The e-dossier link shall be activated from 28/02/2020 to 08/03/2020. The above candidate is also being separately informed through, SMS on his registered mobile number as an additional facility. If the candidate fails to upload required document through e-dossier during the above said period his candidature will be rejected and no further opportunity for uploading in the e-dossier will be given on whatsoever ground.
- 15. Further, wait list / panel for the post code-94/17 shall be valid for a period of one year from the date of declaration of result i.e. upto 14/04/2020 as per earlier **Result Notice No. 403 dated 15.04.2019**.
- 16. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post unless the User Department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
