The DSSSB vide its advertisement no. 02/2018 with closing date 13/08/2018 had advertised 21 vacancies (UR-12, OBC-05, SC-02, ST-02 including 02 EXSM) for the Post of Social Worker under post code 15/18 in Health & Family Welfare Department. The Board had conducted Tier-I (T) written examination on 27/08/2019 (online).
- 2. On the basis of written Examination Tier-I (T) held on 27/08/2019 and having been found provisionally eligible as per documents uploaded in support of Educational Qualification, Age, etc. in accordance with the advertisement no. 02/2018 and RRs for the Post of Social Worker under post code 15/18 in Health & Family Welfare Department, the following Candidates are hereby provisionally nominated as per their merit:-

- * Note: That as per RRs, essential qualification is "Post Graduate Degree in Social Science from recognized University", the User Department has not provided details regarding subjects covered under Post Graduate Degree in Social Science. Therefore, DSSSB has not undertaken the veracity/scrutiny of certificate of essential qualification furnished by the candidates as such User Department i.e. H&FW Department, GNCTD is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the proposed candidate as per nature of job and requirements of the Department. The selection is provisional and subject to satisfaction of User Department regarding essential qualification furnished by above candidates. Further, the desirable experience of the post code 15/18 is "Two years experience in Research Work".
- Candidature of 01 candidate having Roll No. 11151000156 kept pending in EXSM category, as candidate did not uploaded documents related to claim of Exservicemen.
- 4. The above pending candidate is hereby directed to upload his pending documents through e-dossier link on OARS module of the Board within stipulated time. The e-dossier link shall be active from 26.02.2020 to 06.03.2020.
- 5. Candidate having Roll No. **12371000327** has submitted OBC certificate issued by Delhi Govt. on the basis of OBC Certificate of his father issued by Govt. of UP, hence he has been considered in UR Category. Further, his candidature has not been considered in the OBC (Delhi) category.
- 6. The selection of the above 20 candidates (UR-11, OBC-05, SC-01, ST-02 & EXSM-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 7. The Selection of the above 20 candidates (UR-11, OBC-05, SC-01, ST-02 & EXSM-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 8. The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Health & Family Welfare Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates.

The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

- 9. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 10. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.
- 11. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 12. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 13. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is

satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.

- 14. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 15. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
