DRAWING TEACHER, POST CODE-208/14 IN DIRECTORATE OF EDUCATION

- 1. The Result Notice No.212 dated 10/11/2017 was issued as per the eligibility conditions prescribed in the Recruitment Rules. After declaration of the result, some of the candidates had approached the User department, i.e. Directorate of Education for considering their BFA qualification as equivalent to B.A. (Hons) in Art & Art Education and thereby making them eligible for the post of Drawing Teacher within the ambit of the Recruitment Rules. After considering the representations submitted by the candidates, the Directorate of Education has now intimated that candidates having 4 year BFA qualification are to be considered to be having B.A. (Hons.) in Art & Art Education as per the judgment of Hon'ble High Court of Delhi in WP (C) No. 7263/2007 in the matter of Nirmala & Ors. Vs. GNCTD.
- 2. As per the clarification now received from the User department, the result already declared vide Result Notice No.212 dated 10/11/2017 is hereby modified by including the candidates having 4 year BFA degree.
- 3. In view of the modification, as stated above, the revised result for the post of Drawing Teacher, Post Code-208/14 is as under:-

The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned

shall issue the appointment letter to the candidates after satisfying themselves of their eligibility as laid down in the recruitment rules and on verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential Certificates. While getting the Caste Certificates verified from the issuing authority, special attention should be given to the OBC (D) status of the candidate whose roll no. mentioned at SI. No. 01 in OBC Category above before issuing any formal appointment letter as the OBC (D) status of these candidate prima facie appears to be incoherent with the Govt. guidelines in view of the documents now uploaded by them in their respective e-dossiers.

- 5. The date of validity of panel would be one year from the date of declaration of result i.e. 23.05.2019.
- 6. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
- 7. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any.
- 8. This issues with the prior approval of the Competent Authority, DSSSB.
