Mere inclusion of name in the result notice does not confer any right upon the candidates over the post.

Note: - OBC (Outside Delhi) has been treated as UR candidate.

The User deptt should also satisfy itself about the genuineness and veracity of the certificates submitted by the candidates like educational qualification, caste certificates etc., before issuing of offer of appointment. Further, in case of the OBC candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. Of India as per the DOPT notifications issued from time to time in this regard. Further, in case where two or more candidates have obtained equal marks, the User Deptt is advised to prepare seniority list according to their seniority in date of birth of candidates.
