**POST GRADUATE TEACHER (HISTORY) (MALE)
IN DIRECTORATE OF EDUCATION
UNDER POST CODE 171/2014**

The DSSSB vide Result Notice No 485 dated 15.03.2017 had declared the result of 13 candidates for the post of *Post Graduate Teacher (History) (Male)* in Directorate of Education under **Post code 171/2014**.

The candidature of Tunkesh Kumar (26003764) was not considered in postcode 171/2014 at the time of declaration of aforesaid Result as his candidature was pending in Postcode 138/2012 on account of court case in the matter of Anurag Shrivastav. Sh Tunkesh Kumar had scored 160 marks in Tier-II examination and the marks of the last selected candidate in postcode 171/2014 in UR category is 159.25. Since the candidature of Tunkesh Kumar is still pending in postcode 138/2012 on account of court case in the matter of Anurag Shrivastava in Ld CAT having OA No 2234/2015 accordingly his candidature is being provisionally considered in postcode 171/2014, subject to outcome of the pending court matter of Anurag Shrivastava.

The candidature of candidate having Roll number 26002073 was kept pending in OBC category for ascertaining the admissibility of age relaxation to the candidate who is working as Assistant Teacher in MCD. As per OM No 15012/2/2010-Estt(D) dated 27.03.2012 of DOPT regarding the consolidated orders on relaxation in upper age limit allowed to various category of Government servants, it has been clarified in para 3 that the instructions regarding age relaxations including that pertaining to departmental candidates shall not be applicable to personnel working in autonomous/statutory bodies etc, accordingly, the age relaxation to candidate having Roll number 26002073 is not admissible.

In view of above and on the basis of the merit list of Tier- II examination and after preliminary scrutiny of the candidatures as per the provisions of the statutory Recruitment Rules of the post and the terms and

conditions of the advertisement, the following candidates are provisionally selected to the post of PGT (*History*) male under **Post code 171/2014:**

One vacancy in SC category is still pending due to court case in OA 2899/15.

The meritorious candidates who have already been selected for the post of Post Graduate Teacher (History) Male under post code 138/2012, have not been considered for this post, as the DSSSB has conducted the combined examination for the post of 138/2012 and 171/2014.

The selection of the above 02 candidates shall be further subject to through verification of the candidature of the candidate by the User Department. The candidature of the candidates is liable to be cancelled by the User Department, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules of the posts or for any other genuine reason. The decision of the User Department/appointing authority regarding the eligibility of the candidate shall be final and binding on the candidate.

The candidate who had availed the benefit of the reservation at the time of shortlisting of candidates on the basis of Tier I written examination has been considered for final appointment in his respective category only. The User department shall also check the eligibility of the reservation benefit. Further User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the application forms vis-à-vis the original documents. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates before finally appointing the candidate.

Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the appointing

authority is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
