candidate is liable to be cancelled by the user Department also, in case candidate is found not fulfilling the eligibility conditions or any other genuine reason. The user deptt. should satisfy itself of the eligibility of the candidate based on documents submitted by the Candidates relating to educational qualification, caste certificate etc. before issuing offer of appointment.
