INSTRUCTIONS OF EXAM/PHYSICAL ENDURANCE TEST (PET) FOR POST CODE-43/13, HEAD CONSTABLE, TRANSPORT DEPARTMENT.

In compliance of the order dated 92.06.2023 passed by Hon'ble CAT, Principal Bench in r/o O.A. No.923/2017, the PET of Sh. Chandra Dutt for post code-43/13, Head Constable, Transport Department is scheduled to be held on 18.01.2024 at 09:00 AM at East Vinod Nagar Sports Complex, Mayur Vihar, Phase-II, Delhi. The instructions for candidate are given as under:-

- The candidate must report at the 1'est venue strictly as per reporting time given in e-admit Card along with requisite documents. No entry will be allowed after reporting time or without requisite documents under any circumstances.
- 2. The candidate is required to bring his recent colored passport size photograph which is required to be pasted on 1st Page of Admit Card. Further candidate is also directed to bring one post card size photograph (4"x6") (Portrait Style) upper half displaying only Face, both Ears & both Shoulders and it should be Clear & Sharp, which is required to be pasted on the second page of Admit Card matching with his present appearance.

In the presence of invigilator, candidate shall sign 2nd page of Admit Card and also imprint his left hand thumb impression at stipulated place. Candidate shall not sign on the 2nd page of Admit card and put left hand thumb impression on it in the absence of invigilator. In such cases invigilator shall cross such signature and left hand thumb impression and ask candidate to sign and put thumb impression on 2nd page of Admit Card again in his presence and then hand it over to the invigilator. Candidate should ensure that the 2nd page of the Admit Card is handed over to the invigilator as otherwise the candidate himself will be responsible for consequences and keep safely the first page of Admit Card till the time of Joining in respective Department.

- 3. Candidate should bring original E-admit card along with Passport size photograph pasted on 1st Page and one valid Government Photo ID proof (in original) containing clear photograph of the candidate, which could be verified with the face of the candidate. Mutilated/very old ID cards from which candidate could not be verified, will not be allowed to enter the exam venue. No request/plea will be entertained in this regard.
- 4. The candidature of the PET is provisional. The candidate should satisfy himself regarding possession of the required qualification, age, caste and admissibility of benefit of reservation etc. as stipulated for the post he has applied for, as on the cutoff date, before appearing in the examination. The candidature will be treated as **invalid**, *ab-initio*, in case he does not fulfill the eligibility criteria.
- 5. The candidate should not bring any article in the examination hall except mentioned in the admit card.
- 6. Travelling and other expenses shall be borne by the candidate himself. The Board does not make any arrangements for the lodging and boarding of the candidate.

- 7. In presence of Invigilator, Candidate should write his particulars wherever required and should put his signature at the space provided. Candidate should put his left hand thumb impression on the space provided in the Admit Card, Attendance Sheet and Answer sheet in the presence of the invigilator. Thereafter, the invigilator will sign on the Admit Card.
- 8. Candidate must abide by the further instructions, which may be given to him by the Centre Supdt./Invigilator/board staff etc. If candidate fails to do so or indulges in disorderly or improper conduct he will render himself liable to expulsion from the Test as well as other penalty as the Board may deem fit to impose.
- If candidate is found using any unfair means, conspiracy, cheating, fraud, forgery, impersonation or any unlawful act he will be debarred from all examinations of DSSSB and necessary legal action will be initiated.
- 10. The candidature of the candidate to the PET is entirely provisional and subject to the outcome of any direction/decision/order/pronouncement of any court of law and mere issue of admit card or appearance at Examination/Skill Test does not entitled him any claim for the post.
- 11. The Board reserves the right to cancel a part of or entire process of examination/test due to administrative reason(s) and in case of unfair means, cheating or other irregularities/malpractice noticed by the Board. The Board also reserves the right to cancel or set up a new examination centre and divert the candidate to appear at that examination centre if required.
- 12. The decision of the Board in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, conduct of examination(s) and allotment of examination centres, selection and allotment of posts/organizations to selected candidates will be final and binding on the candidate and no enquiry/correspondence will be entertained in this regard.
- 13. The Board reserves the right to reject the candidature of ineligible candidate at any stage of recruitment. Further, candidature of candidate is purely provisional, at every stage until he is offered appointment by the concerned Department to which the post belongs, after due verification of documents and eligibility in respect of the post.
- 14. Prohibited Items for Candidate in the Exam. The candidate is not allowed to carry any communication device like Mobile Phone etc. and any other items which may cause hindrance to conduct of examination.
- 15. No arrangement will be made at the Centres for keeping any articles/items belongings to the candidates.
- 16. The candidate is strictly advised to wear vest/T-shirt for affixing chest badge for clear identification during Physical Endurance Test (PET).
- 17. No request of the candidate for change in date, time and centre of Test will be accepted under any circumstance.
