ORDER

1. The Board has been mandated to make recruitment to Group 'B' (Non-Gazetted) and Group 'C' posts of various departments of Govt. of NCT of Delhi and its local/autonomous bodies. The indenting departments forward the requisition of the vacancy of the post alongwith the Recruitment Rules. The Board makes recruitment as per the qualifications prescribed in the RRs.

2. The vacancy requisition for different posts of TGTs was received in the year 2013 from the Dte. Of Education vide letter no. F.DE. 3(75) DR/Notification/2012/01 dt.02/01/2013 and the vacancies were advertised vide Advertisement No. 01/2013 from post codes 04/13-19/13 alongwith some other post codes of different posts. Applications were invited from the candidates who fulfilled the eligibility criteria as on the cutoff date i.e. 20/03/2013. Applicants were requested to submit their applications only on the prescribed OMR application forms.

3. In para 8 of the advertisement the candidates were advised to scrupulously observe the following instructions in connection with filing of applications:-

8. HOW TO APPLY

- i) The candidate must apply in the prescribed OMR application form available at DSSSB and DC (Revenue) offices at North-East, North, North West, West, South & South West
- ii) No document should be attached with the OMR application. The OMR application form should not be folded or stapled. In case, the OMR form is folded/stapled or any document is attached, the application shall be rejected
- iii) The application form should be filled up using Blue/Black ball pen only.
- iv) The candidate must write his/her Name, Father's/Husband's name and Date of Birth as it appears in the Matriculation/Secondary Certificate or equivalent. If the candidate has changed his/her name after matriculation, his/her father's name, her husband's name, necessary documentary proof/affidavit issued by a First Class Magistrate should be furnished at the time of verification of documents.
- v) Recent passport size coloured photographs (front face) with light background as per specification should be pasted on application form.
- vi) All columns must be filled. **No column should be left blank, instead it should be marked "NA" wherever not applicable.** Incomplete or illegible or incorrectly filled or unsigned application form will be summarily rejected. Candidate must sign in the running script, not in block letters in the same language.
- vii) Candidate must sign in running script and put his/her left thumb ink impression in relevant columns of application form which must be clearly visible.

4. **Further, in para 9 of the advertisement it was clearly mentioned that the application form with any of the following deficiencies or irregularities will be treated as invalid and summarily rejected:**

- a. Application form not in prescribed OMR Format or Application form in Newspaper cutting or submitted before opening date or after closing date.
- b. Post name and Post Code(s) not filled up or incorrectly filled up.
- c. OMR application form not filled up or not filled up as per direction given in the Notice.
- d. Incomplete or illegible or incorrectly filled up applications.
- e. Without passport size coloured photograph (front face) with light background affixed on application form in the space provided. Affixing Black and White/polaroid and blurred photographs. Affixing more than one type of photograph.
- f. Without signature and left hand thumb ink impression in space provided.
- g. The application filled up in other than Blue/Black ball pen.
- h. Signature done in Block/Capital letters in English or in different languages and in different style/mode or any variance in the signature.
- i. The Left thumb ink impression not clearly visible.
- j. Applications not filled in by candidate in his/her own handwriting.
- k. Under/over aged candidates.
- l. Not having the requisite qualifications as on closing date.
- m. More than one application for the post by the same candidate for the same post.
- n. Applications of more than one candidate or more than one post code sent in one envelope.
- o. Application from a candidate debarred from appearing in the Exam by the DSSSB/SSC for life time or for a particular period.
- p. Any other irregularity

5. It was also clearly mentioned in the note below para 9 of the advertisement that **"No claim for re-consideration of the rejected cases on the grounds specified above will be entertained."**

6. **Further, in para 11 of the said advertisement it was stipulated that the candidature of the candidates will be cancelled in following conditions:**

"(i) The candidates applying for the posts should ensure that they fulfill all the eligibility conditions. Merely because a candidate has been allowed to appear in the examination will not be considered as a valid ground for his/her being eligible for the selection. If on verification at any time before or after the written examination or at any stage of recruitment process, it is found that they do not fulfill any of the eligibility conditions, his/her candidature for the post applied for, will be cancelled by the Board/Appointing Authority.

(ii) Candidates are cautioned that they should not furnish any incomplete or false information or indulge in impersonation or submit any document which is defective or fabricated or otherwise commit any act of misconduct in submitting the application forms or during the course of recruitment or fraudulently claim SC/ST/OBC etc. and other benefits. In the event if any such case is detected, the Board/Appointing Authority reserves its right to withdraw/cancel any selection and take legal action against the candidate concerned. The candidate may be permanently or for a specified period **debarred from taking part in the recruitments conducted by the Board."**

7. In para 14 of the said advertisement it was also laid down that The decision of the Delhi Subordinate Services Selection Board in all matters relating to eligibility, acceptance or rejection of the application, penalty for false information /misconduct, mode of selection, conduct of examination(s) and allotment of Exam centers, selection and allotment of post/organizations to the selected candidates will be final and binding on the candidates and no enquiry/correspondence will be entertained in this regard.

8. Accordingly, all the application forms received against the posts of TGTs were scrutinized and out of total 31691 application forms 13111 were found valid and lists of eligible and ineligible candidates were uploaded on the website of the Board vide notice dated 10/09/2013 **wherein applicants were instructed to submit their representations with documentary evidence up to 20/09/2013 in case they have any objection about their eligibility/ineligibility.**

9. After scrutinizing all the representations the Board considered some candidates as additional eligible and total 13873 candidates were considered eligible for the posts of TGTs (post codes 04/13-19/13).

10. Some of the aggrieved candidates who were declared ineligible by the Board filed petition in the Hon'ble CAT and as per direction of the CAT provisional admit cards were issued to them and they were provisionally allowed to take the examination.

11. Sh. Neetej Mathur had also applied for the post code 06/13, As per the RRs he was required to fulfill following qualifications:

(i)- B.A.(Honours) in one of the Modern Indian Languages (MIL) concerned or BA with MIL concerned as one of the Elective subjects from a recognized University having 45 % marks in aggregate with one additional language or one school subject at Degree Level.

OR

Equivalent Oriental Degree in MIL concerned from a recognized University having 45% marks in aggregate.

OR

(For appointment as Hindi Teachers only) Sahitya Rattan of Hindi Sahitya Sammelan Prayag having secured at least 45% marks in aggregate with English in Matriculation provided further that the requirement as to the minimum of 45% marks in the aggregate shall be relaxable in the case of (a) candidate who possess a Post Graduate Qualification in MIL concerned from a recognized University (b) candidates belonging to SC/ST (c) Physically handicapped candidates.

(ii) Degree/Diploma in teaching OR Senior Anglo Vernacular Certificate. (iii) " Knowledge of Hindi is essential". (iv) Central Teacher Eligibility Test conducted by CBSE.

N.B. :- "The candidate should have studied the subject concerned as mentioned in the RRs in all parts/years of graduation. The elective word may also include main subject as practiced in different Universities".

12. During the course of scrutiny of his application, it was noticed that he had not darkened the circle/bubble in his OMR application form relating to "Additional language in B.A. & No degree/diploma in teaching or SAV Certificate." As such his

application was rejected for not having the requisite qualification as per RRs/advertisement with the following reasons: **"NOT HAVING THE REQUISITE QUALIFICATION AS ON CLOSING DATE"**.

13. The Board conducted combined examination on 28/12/2014 for the posts of TGTs (04/13-19/13) advertised in the year 2013 alongwith the other post codes of TGTs advertised in the year 2012. All the candidates who were issued provisional admit cards on the direction of hon'ble CAT were also considered as candidate for the post code for which they were allowed provisionally by the hon'ble CAT.

14. Sh. Neetej Mathur was issued admit card for the Post code 108/12. He was not considered eligible for the Post code 06/13.

15. The Hon'ble CAT has passed orders dated 30.11.2016, in OA No. 472/2015, in the matter of Neetej Mathur Vs. GNCTD & Ors. The operative part of the order is as under:-

"We direct the respondents to consider the candidature of the applicant for the post code 06/13 on the basis of his performance in the common examination for both Post Codes 108/12 and 06/13 after verifying his qualifications otherwise satisfying themselves with suitability in accordance with law, within four weeks from the date of receipt of copy of this order.

With the aforesaid observation and direction, the O.A. is disposed of.
No Costs."

16. The case of the applicant was again examined in light of the order dated 30/11/2016 and it has been observed that:-

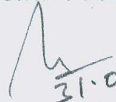
- (i) Sh. Neetej Mathur has already been provisionally selected against the Post code 108/12 (TGT Hindi-Male) vide Result Notice No. 23 dated 03/06/16 and his dossier has already been forwarded vide letter dated 17/06/2016 to user department.
- (ii) Since Sh. Neetej Mathur have already been selected for the same post and for the same department, his candidature for the Post Code 06/13 cannot be considered. The case of Sh. Neetej Mathur is accordingly disposed off.

18. This issues with the approval of Competent Authority and in compliance of the directions of Hon'ble CAT in O.A. No. 472/2015.

19. Let this order be served upon the above-mentioned applicant through Speed Post.
