- 1. The DSSSB vide its advertisement no. 01/2017 with closing date 21/08/2017 had advertised 01 vacancy (UR-01) for the Post of Librarian under post code 10/17 in Directorate of Training (UTCS). Board Conducted Tier-I written examination for recruitment in respect of this post on 01/09/2019.
- 2. The marks statement of the candidates has been uploaded on OARS Module of the Board for information of the candidates. All the candidates can view their marks by logging into their account in the OARS Module on www.dsssbonline.nic.in.
- 3. The candidate having roll number 3590000214 belongs to SC Category. Since the vacancy is advertised for UR Category, the candidate was considered in UR Category. The candidate being overage in UR category, considered not qualified for the Post in UR Category.
- 4. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in One Tier written examination for UR Category Candidate is 40%.
- 5. The shortlisted candidates for the above-mentioned post/post code are hereby informed to fill the e-dossier and up-load all the documents of Educational Certificate/Experience Certificates and Marks sheets/Caste Certificate/Proof of Govt. Servant/Ex Servicemen/Admit Cards, etc., as applicable in the e-dossier module in OARS link in their individual accounts in OARS module.
- 6. The category wise cut off marks for uploading e-dossier have been given as under:-

7. The link for up-loading e-dossier shall be kept open for a period of 15 days with effect from 18/11/2019 to 02/12/2019. The candidates uploading e-dossier should ensure that he fulfills all the eligibility criteria as on the cutoff date, i.e., 21/08/2017. The shortlisted candidates are also being separately informed through SMS & E-Mail on their registered mobile number and e-mail ID. If any candidates fails to upload the e-dossier during the

above said period, his candidature will be rejected and no further opportunity for uploading e-dossier will be given on whatsoever grounds.

- 8. Mere asking the candidate for up-loading documents in the e-dossier module does not confer upon him/her any right to selection to the applied post. Final selection will be made purely on the basis of merit against the notified vacancies provided the candidate falling in the zone of consideration fulfills all the required eligibility conditions. It is reiterated that if the candidate fails to upload his documents on or before the date as mentioned above he will not be given any further opportunity and his candidature will be treated as cancelled.
- 9. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
