NOTICE NO. 87-2 Legal Assistant, Post Code-83/17 In Directorate of Education, GNCTD.

- 1. The DSSSB vide its advertisement no. 03/2017 with closing date 21/11/2017 had advertised 13 vacancies (UR-9, OBC-3 & SC-01) for the Post of Legal Assistant under post code 83/17 in Dte. of Education. Board Conducted Tier-I (T) written examination for recruitment in respect of this post on 29/09/2019.
- 2. The marks obtained by **566** candidates who have duly appeared in written examination held on 29/09/2019 have been uploaded on Board's website. Candidates can view their marks by logging into their account in the OARS Module on www.dsssbonline.nic.in.
- 3. Based on the performance in Tier-I written examination, 133 candidates as detailed below, have been provisionally shortlisted to appear in Tier-II examination subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms. The shortlisted candidates shall be called for Tier-II examination separately.

- 4. Only those candidates have been considered in OBC category who has declared that they had obtained their caste certificate from Delhi State in their online examination form.
- 5. Since documents have not been called from the candidates along-with the application forms as such detailed scrutiny regarding eligibility has not been carried out, and therefore, mere inclusion of name in the list of candidates qualifying for appearing in Tier-II examination does not entitled them any right over the post.
- 6. Reserved category candidates who have obtained marks above or equal to last shortlisted UR candidates have been shortlisted against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.
- 7. As per the Board Notice dated 26/04/2013 the minimum qualifying marks in One Tier written examination for UR category candidate is 40%, for OBC candidate is 35 and for SC/ST/PH is 30%.

- 8. The qualified candidates for appearing in Tier-II examination have been called in the ratio of 1:10 of the advertised vacancies, however all the candidates who have scored marks equal to the cut off marks in each category have been shortlisted.
- 9. While every care has been taken in preparing the list of shortlisted candidates, DSSSB reserves the right to rectify errors and omissions if any, detected at any later stage.
