**ORDER**

1. This order is being passed in compliance with the directions/Order dated 20.12.2024 of Hon'ble Central Administrative Tribunal (CAT), Principal Bench, New Delhi in O.A.No. 2648/2021.
2. Brief facts of the case : -
  - i. As per requisition received from the Municipal Corporation of Delhi (MCD) the DSSSB vide its Advertisement No. 03/2013 had advertised posts of Lower Division Clerk in the MCD under Post code 51/13 alongwith its last date of submission of application form as 18.10.2013. The Tier-I Written examination was held on 24.10.2019, 25.10.2019 and 23.02.2020.
  - ii. Sh. Mandeep Singh had also applied for the said Post and his details are as under:-

- iii. Sh. Mandeep Singh s/o Sh. Joginder Singh was debarred from appearing in any examination conducted/to be conducted by the DSSSB for lifetime w.e.f. 24.10.2019 vide Order No. F.55(277)/EXAM/DSSSB/2021/10813-20 dated 02.09.2021. Consequently, the candidature of Sh. Mandeep Singh S/o Sh. Joginder Singh bearing Roll No. 11290600521 was also cancelled for the post code 51/23 vide Candidature Cancellation Notice No. 1273 issued vide Number F.1(430)/CC-II/DSSSB/2020/3310-3323 dated 21.10.2021.

- iv. Sh. Mandeep Singh challenged both the above Orders of DSSSB in Hon'ble CAT by filing O.A. No. 2648/2021. The Hon'ble Tribunal vide Order dated 20.12.2024 allowed the O.A. No. 2648/2021 with following observations/directions:-

*"8. Today, the concerned officers of EDCIL appeared in person and along with the counsel of DSSSB stated that they are ready to examine the genuineness and bona fides of the applicant's finger print and photograph with the help of their technical advisors – Tata Consultancy Services (TCS) after calling the applicant to their office on a mutually convenient date. Further, if both the finger prints and photograph match during this exercise, the charge of impersonation would be dropped and the applicant would be considered suitable for this job. The applicant's counsel also agreed to this proposal.*

*Accordingly, we allow the OA by quashing and setting aside the impugned order No. F.55 (277)/EXAM/DSSSB/2021/10813-20 dated 02.09.2021 and No. F.1 (430)/CC-II/DSSSB/2020/3310- 3323 dated 21.10.2021. The respondents i.e., EDCIL along with DSSSB are directed to call the applicant to EDCIL's office on a convenient date ; carry out the above mentioned exercise within a period of six weeks from the date of receipt of certified copy of this order and if the finger print and photograph matches and if the applicant is otherwise found fit on merit and medical grounds consider his candidature for appointment to the post of Lower Division Clerks (Post Code 51/13) with all notional benefits like fixation of pay and allowances and seniority. However, there will be no payment of arrears of pay and allowances on the principle of 'No work no pay'. There will be no order as to costs.*

*Pending M.A(s) if any, also stand disposed of accordingly."*

- v. In compliance with the Order dated 20.12.2024 of Hon'ble Tribunal in O.A. No. 2648/2021 and after re-examination of the case of the Candidate by the Departmental Committee with recommendations vide Minute of Meeting bearing No. F.55(277)/ Exam/DSSSB/2021/93 dated 13.02.2025, the Order regarding debarment of Sh. Mandeep Singh from appearing in any examination conducted/to be conducted by the DSSSB for lifetime w.e.f. 24.10.2019 has been withdrawn retrospectively vide Order No. F.55(277)/Exam/DSSSB/2021/103-114 dated 20.02.2025.



3. Consequently, the Candidature Cancellation Notice No.1273 issued vide No. F.1(430)/CC-II/DSSSB/ 2020/3310-3323 dated 21.10.2021 in r/o Sh. Mandeep Singh (Roll No. 11290600521) is also hereby withdrawn retrospectively.
4. Further, against total 345 vacancies for the Post of Lower Division Clerk in the MCD under Post code 51/13, only 93 vacancies were reserved for OBC candidates. Out of these, 83 (82+1 OH) vacancies have been filled vide Result Notice Number 1297 dated 21.10.2021. 10 vacancies of OBC remained unfilled being reserved for ExSM-08, VH-01 and HH-01. The marks of last selected candidate in OBC category were 124.04. Sh. Mandeep Singh secured 113.59 marks out of 200 and there are still 105 candidates above Sh. Mandeep Singh in marks list/merit list of OBC Category who have not be been selected being in waiting list and waiting panel has already been expired on 20.10.2022.
5. In view of this, the candidature of Sh. Mandeep Singh (Roll No. 11290600521) cannot be considered for the Post of Lower Division Clerk in the MCD under Post code 51/13 as he does not come in merit and there are still 105 candidates above him in marks list/Merit List of OBC Category who have not been selected being in waiting list and waiting panel has already been expired on 20.10.2022.
6. This issues in compliance with the directions of Hon'ble CAT vide Order dated 20.12.2024 in OA No. 2648/2021 and with the approval of Competent Authority.
7. Let this order be served upon Sh. Mandeep Singh (Roll No. 11290600521), a candidate for the post of Lower Division Clerk in the MCD under Post code 51/13.
