SUPPLEMENTARY RESULT NOTICE NO:278 For the post of Counselor, under Post Code- 45/21 in Department of Women and Child Development, GNCTD.

- 1. This is in continuation of Result Notice No. 143 Dated 27.07.2022.
- 2. DSSSB vide Result Notice No. 143 dated 27.07.2022 provisionally nominated total 50 Candidates [UR-22 (incl. PH-OH-01), EWS-05, OBC-13 (incl PH-OH-01), SC-07, ST-03] and waiting panel of total 13 Candidates [UR-05, EWS-01, OBC-03, SC-02, ST-01, Incl. PH-OH-01] for the Post of Counselor under Post Code- 45/21 in Department of Women and Child Development (WCD), GNCTD subject to their fulfilling all other conditions of eligibility and correctness of information furnished by the candidate in their online applicant form and e-dossier.
- 3. The User Department i.e. Department of Women and Child Development, GNCTD vide letter No. 8(92)/Admn./WCD/Counselor/Part File/2022/1968-70 dated 04.05.2023, 8(65)/WCD/Admn./Prison/Counselor/2023/4689-99 dated 16.06.2023, 8(92)/Admn./WCD/Counselor(Appointment)/2023/6637 dated 24.07.2023, 8(92)/WCD/Admn./Counselor(Appointment)/2022/14322-25 dated 04.12.2023, and F.8(92)/Admn./WCD/Counselor(Appointment)/2022/19151-53 dated 18.02.2025 (revised report/data) has informed that all the provisionally nominated and waitlisted candidates under UR and OBC Categories have been utilized and requested to provide e-dossiers of eligible candidates from the reserve panel of said categories under post code 45/21.
- 4. The validity of the reserve panel of post code 45/21 was up to 26.07.2023. WCD vide letter No. F.8(92)/Admn./WCD/Counselor(Appointment)/2022/19151-53 dated 18.02.2025 has provided revised status report for all provisionally nominated and wait list candidate and vacancy position of all categories upto 26.07.2023. Hence, as per Board's resolution dated 19th May, 2021 in supersession of earlier policy dated 13 June 2019 and in accordance with Services Department Circular No. F.16(3)/DSSSB/2007-S-III/1756-1763 dated 02/08/2021, out of the waiting/reserve panel comprising all the candidates above minimum qualifying marks in Written Examination, following candidates are hereby provisionally nominated in the categories/vacancies of UR-02 & OBC-04 from Reserve Panel against the vacancies arose till expiry of Reserve Panel i.e. 26.07.2023 under post code 45/21 purely on the basis of marks obtained by the candidates in the examination held on Online Exam conducted on 20.02.2022 and also claims made by the candidates in their online application forms of the post code 45/21 for the post of Counselor in Department of Women and Child Development, GNCTD.
- 5. Accordingly, in continuation of Result Notice no. 143 dated 27.07.2022, the candidates, as detailed below are provisionally nominated purely on the basis of marks obtained by the candidates in online examination and considering other relaxations, if any claimed by the candidate in their online application forms of the post code 45/21 for the post of Counselor in Department of Women and Child Development, GNCTD. The Board has not undertaken any scrutiny of documents uploaded in the e-dossier at this stage as per Board's resolution/decision dated 14/07/2022. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement number 02/21 and relaxations as per rules in respect of educational qualifications, age experience, etc., shall be scrutinized/ verified by the User Department for determining eligibility of the candidates for the post code 45/21 as on cut-off date 24.06.2021 (as per Notice No. F.1(603)/P&P/DSSSB/2021/Advt./5110 dated 12.05.2021) before issuance of offer of appointment to the post.

(**Note:** Therefore, total 05 candidates in OBC category are hereby provisionally nominated against 04 vacancies of OBC. Since 01 candidate (roll no. 121104500355) was already provisionally nominated in OBC category at the time of issuance of main result notice no 143 dated 27.07.2022 and as per status report provided by WCD, the candidate has also joined in OBC category with WCD. As per supplementary result, this 01 OBC candidate is now provisionally nominated in UR category on the basis of merit and may be shift from OBC to UR category by WCD.

- **6.** The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 02/21 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 45/21 as on cut-off date 24.06.2021, before issuance of offer of appointment to the post.
- 7. The provisional nomination of the above total-06 candidates shall be further subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement and subject to thorough verification of their identity with reference to their photographs, signature/ handwriting etc. on the application form, admission certificate etc. by the User Department. The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate does not fulfill any of the eligibility conditions of the Recruitment Rules for the post or for any genuine reason. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate. The Competent Authority of the User Department concerned shall issue the offer of appointment to the candidate after being satisfied about his/her eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 8. The User Department shall also check the eligibility of the reservation benefit claimed by the candidates, if any. Further, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate, if applicable. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the application forms and e-dossier vis-à-vis the original documents. The User Department is requested to ascertain the scrutiny/correctness of the same at its own level before issuing the offer of appointment to the provisionally selected candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at its own level.
- 9. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22/93-Estt. (SCT)dated 08/09/1993 issued by DOPT and other instructions/ guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It

is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC(Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt, GNCTD after thorough verification of caste certificate.

- 10.User Department shall also get the SC/ST/OBC/EWS/PH (with sub category) certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14/10/2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017 and other instructions/ guidelines issued from time to time by the competent authorities.
- 11.Further, in case of EWS candidates, it may also be verified that the validity of EWS certificate should be as per DOPT OM No. 36039/1/2019-ESTT(Res) dated 31.01.2019 and other instructions/ guidelines issued from time to time in this regard by the competent authorities.
- 12.The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after verification of the correctness of the information furnished in the application form/e-dossier and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 13. The User Department, shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 14. The category wise marks secured by the last provisionally nominated candidate is as under:

- 15. The result process for the above post code stands closed in all respect. Waiting panel was valid for a period of one year from the date of declaration of result i.e. upto 26.07.2023 as per Main Result Notice No. 143 dated 27.07.2022. The current supplementary result is declared against the orders of cancellation of candidature issued by the User Department i.e. WCD well before expiry of waiting/Reserve Panel and complete status report provided by WCD vide their letter no. F.8(92)/Admn./WCD/Counselor(Appointment)/2022/19151-53 dated 18.02.2025.
- 16. The candidates in the Waiting Panel or the Balance Reserve Panel shall have no claim or right for appointment per se against the vacancies notified for the recruitment. Nomination of above candidates from Reserve Panel is on the basis of complete status report provided by WCD and orders of cancellation of candidatures issued by WCD till 26.07.2023, i.e. within validity period in respective categories/Sub-categories. They can only get the offer of appointment only in the event any vacancies (category-wise) arising due to non-acceptance of the offer of appointment, not joining the post after acceptance of appointment, resignation after joining & no. of vacancies etc.
- 17. User Department being Cadre Controlling Appointment Authority shall utilize the Waiting/Reserve Panel subject to availability of candidates in respective categories/Subcategories and purely on the basis of merit following the relevant circulars/OMs guidelines issued by the Government.
- 18. While operating the Waiting Panel/Reserve Panel list, the User Department shall strictly follow instructions issued vide DoPT OM No. 36012/2/96-Estt. (Res) dated 02/07/1997, 36011/1/98-Estt. (Res) dated 01/07/1998 and 43011/4/2018-Estt. (Res) dated 04/04/2018 regarding shifting of candidates from respective reserve categories to the unreserve category.

- **19.** The user department shall operate the Waiting Panel/Reserve Panel up to the number of vacancies notified under each category by the DSSSB in its advertisement and not beyond it even by taking any type of relaxation from any authority, as it shall be rendered the excess appointment void and illegal *Ab initio*.
- **20.** The result is subject to the outcome of the court cases, if any, pending in various courts related to this post. The user department shall decide such cases subject to outcome of court case(s), if any.
- **21.** While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 22. This issues with the prior approval of the Chairman, DSSSB.
