ORDER

WHEREAS, As per requisition received from the Directorate of Education, GNCTD, the DSSSB vide its Advertisement No. 02/2012 had advertised posts of PGT (Political Science) –Male in the Directorate of Education under Post code 149/12.

AND WHEREAS, For the post code 149/12, offline applications were invited. Later on, it was decided that all candidates of Advt. No. 02/12(which included post code 149/12 also) will submit their application on OARS portal.

AND WHEREAS, Sh. Rajesh Sharma had applied for the post of PGT (Political Science)-Male under post code 149/12 in offline mode. The information available on OARS portal indicate that he failed to re-apply for the post code 149/12 on OARS portal. Against his application ID No. 2278633, he had submitted application for the post code 143/12 - PGT (Music)-Male.

AND WHEREAS, Before conducting any examination for the post code 149/12, another advertisement was released by DSSSB for the post of PGT (Political Science)-Male under post code 175/14. The applicant Sh. Rajesh Sharma applied against this post code also. He was allotted Roll No. 34001474.

AND WHEREAS, A common examination was conducted for the post codes 149/12 and 175/14. The candidature of Sh. Rajesh Sharma was considered for the post code 175/14 only because his candidature for the post code 149/12 was rejected due to incomplete application in OARS portal. The marks of the last selected candidate in post code 175/14 in UR Category were 151 and the marks obtained by the applicant were as under: -

AND WHEREAS, The marks of Sh. Rajesh Sharma were less than the marks of last selected candidate, he was not selected for the post in post code 175/14.

AND WHEREAS, Sh. Rajesh Sharma filed O.A. No. 1327/2017 in Hon'ble Central Administrative Tribunal (CAT) challenging the decision of DSSSB for not considering his candidature for the Post of PGT (Political Science-Male) in post code 149/12.

AND WHEREAS, Hon'ble CAT vide Order dated 11.11.2024 in OA No. 1327/ 2017 directed as under: -

"23. Accordingly, the OA is disposed of with a direction to the respondents to consider the candidature of the applicant under post Code 149/12, in accordance with his merit position. In case the applicant is fit for appointment otherwise, he shall be considered and issued the appointment letter within three months from the date of receipt of a certified copy of this order. He shall be entitled to all consequential benefits except back wages.

24. OA is allowed in the aforesaid manner. MA, if any, also stands disposed of.

25. No order as to costs."

AND WHEREAS, Against total 74 vacancies under Post code-149/12, 40 vacancies were for UR candidates and out of which 30+2(VH) were filled and remaining 08 unfilled vacancies of UR were returned to the user department alongwith other vacancies for inclusion in next requisition. The marks of last nominated candidate vide Result Notice No. 720 dated 27.09.2018 in post code 149/12 in UR Category were 147. The cut off marks of Wait list candidate in UR category were 145.25.

AND WHEREAS, There are still 17 candidates, whose marks are above in merit from Sh. Rajesh Sharma (DOB: 28.04.1985) as per Merit list of Post Code 149/12.

NOW THEREFORE, The candidature of Sh. Rajesh Sharma (DOB: 28.04.1985) cannot be considered for the Post of PGT (Political Science-Male) under Post Code 149/12 as he is not found to be qualified in merit and there are still 17 candidates whose marks are above him in marks list/Merit List of UR and they have not been selected as the waiting panel for the post code has already been expired on 16.03.2018.

This issues with the prior approval of the Competent Authority and in compliance with the directions of Hon'ble C.A.T. vide Order dated 11.11.2024 in OA No. No. 1327/2017.
