## SUPPLEMENTARY RESULT NOTICE No.: 1549 TEACHER (PRIMARY) POST CODE-16/2008 MUNICIPAL CORPORATION OF DELHI

- The DSSSB vide its advertisement No. 02/2008 had advertised 1000 vacancies (UR-505, OBC-270, SC-150 & ST-75) for the Post of Teacher (Primary) under post code 16/2008 in Municipal Corporation of Delhi, with closing date 12.08.2008.
- 2. The Result of the Main exam for the post of Teacher (Primary) of those candidates who passed the preliminary exam including the SC category was declared on 27.08.2009.
- 3. DSSSB in compliance of the judgment dated 04.08.2009 of Hon'ble Supreme Court of India as passed in Civil Appeal No. 5092/2009 in the matter of Subhash Chandra Vs DSSSB & Ors., did not consider SC/ST candidates of states other than Delhi origin as eligible for admissibility of benefits of reservation.
- 4. On scrutiny of dossiers and on the basis of SC Caste Certificate of Outside Delhi state enclosed with application forms, the following candidates were not found eligible for the benefit of reservation under SC category as per the judgment of Subhash Chandra and therefore, the candidatures of these candidates were not considered for the said post:-
  - 1. Sh. Satya Narayan Arya (Roll No. 1631518)
  - 2. Sh. Sanjay Kumar (Roll No. 1628578)
  - 3. Sh. Dinesh (Roll No. 1627771)
  - 4. Sh. Jitender Singh (Roll No. 1629687)
- 5. The applicants filed OA No. 913/2016 on 24.02.2016 before the Central Administrative Tribunal seeking directions to the DSSSB to consider their case for appointment as Teacher (Primary) MCD under post code 16/08 under the SC Category as per merit position against the unfilled vacancies of the advertisement No. 02/08.

6. The Ld. Tribunal vide order 30.07.2019, directed as under:-

"6. Thus, in view of the law laid down by the Hon'ble Supreme Court and in view of the facts narrated above, this OA requires to be allowed. Accordingly, the OA is allowed and the impugned six orders dated 21.01.2013 (which is collectively produced as Annexure A-7 (Colly) and order dated 19.05.2014 produced as Annexure A-1 are set aside. The respondents are directed to appoint the applicants against unfilled reserved vacancies meant for the category of SC as recorded in the result Notice no. 46 dated 06.10.2009 with all consequential benefits, but however, the applicants are not entitled for any back wages. MAs pending, if any, stand disposed of. The respondents are directed to comply with the above directions within a period of three months from the date of receipt of copy of this order. No order as to costs."

- 7. The above Order dated 30.07.2019 of Hon'ble CAT in OA No. 913/2016 was challenged by DSSSB in Hon'ble Delhi High Court by filing Writ Petition vide W.P.(C) No. 971/2020. Hon'ble Delhi High Court vide Order dated 22.10.2024 dismissed the petition. Further, the Special Leave Petition filed in Hon'ble Supreme Court of India in this regard vide SLP (C) No. 14737/2025 has also been dismissed by the Hon'ble Court vide order dated 19.05.2025.
- 8. Vide Supplementary Result Notice No. 815 dated 29.08.2019 issued in compliance with the directions of Hon'ble Supreme Court of India Order dated 30.08.2018 in the matter of Bir Singh & Ors V/s Delhi Jal Board & Ors. in Civil Appeal No.1085/2013 tagged Civil Appeal No. 8141/2014 titled as Mukesh Kumar & Ors. V/s DSSSB & Ors., it was declared that the cut-off marks for selection of candidates in SC Category for Post Code 16/2008 came to 104 marks which was earlier 94 marks. The same submissions were also made in the Counter Affidavit submitted in Hon'ble Supreme Court of India in Contempt Petition (C) No. 751 of 2019 in Civil Appeal No. 8141 of 2014.
- 9. In view of this, in compliance with the Order dated 30.07.2019 of Hon'ble CAT in OA No. 913/2016, upheld by Hon'ble Delhi High Court vide Order dated 22.10.2024 and Hon'ble Supreme Court of India vide Order dated 19.05.2025 in SLP (C) No. 14737/2025, the following 04 (Four) candidates are hereby provisionally nominated, under SC Category, for the post of Teacher (Primary) under post code 16/2008 in Municipal Corporation of Delhi, subject to fulfilling all others conditions of eligibility and also correctness of information furnished by the candidate in their application forms and dossiers: -

- 10. Further, the Elementary Teacher Education (ETE) courses and the validity of the ETE courses done by the candidates, specifically in r/o Sh. Sanjay Kumar (Roll No. 1628578), are to be checked by the User Department to ascertain their eligibility for the post.
- 11. As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, no scrutiny of documents in the dossier and of the other terms and conditions of recruitment notified by the Board in the advertisement of the said post code has been done by the Board. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advt. No. 02/2008 and relaxation as per rules in respect of educational qualifications, experience, other certificates shall be scrutinized/verified by the User Department for determining eligibility of the candidates for the Post Code 16/2008, before issuance of offer of appointment of the post.
- 12. The provisional nomination of the above 04 candidates (SC Category) shall be further subject to thorough verification of the candidature of the candidates by the User Department including the identity of the candidates.
- 13. The provisional nomination of the above 04 candidates (SC Category) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting, etc. in the application forms, admission certificates, etc. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application forms and the documents related to Educational Qualification, Age and other essential certificates.
- 14. The User Department i.e. MCD shall verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the dossier vis-à-vis the original

documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidates. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidates at their own level.

- 15. It is stated that the User Department shall verify the genuineness of the caste certificates furnished by the candidates, in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities, prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 16. The User Department shall also get the SC/ST/OBC/EWS certificates verified from the issuing authority before her appointment. Further, in case of OBC Candidate, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No.36033/3/2004-Estt. (Res) dated 14/10/2008 OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017 OM No. 36039/1/2019-Estt. (Res) dated 31/01/2019.
- 17. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about their eligibility as laid down in the recruitment Rules and after verification of the correctness of the information furnished in the application forms and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 18. The User Department shall ensure that the appointments made are in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 19. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- The recruitment process for the Post of Teacher (Primary) under post code 16/2008 in Municipal Corporation of Delhi has already been closed.

Further, the Wait List panel of the candidates had already been expired on 05.10.2010.

- 21. Mere inclusion of the name of candidates in the result notice does not confer any right upon the candidates over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidates are suitable in all respect for appointment to the Post.
- 22. The nomination of the candidates is subject to outcome of review petition filed in the matter, if any. Further, the User Department shall also ensure that subsequent appointment and any other action will be subject to outcome of review petition/court case filed in the matter at any stage.
