## SUPPLEMENTARY RESULT NOTICE NO.: 1559 OCCUPATIONAL THERAPIST/ RECREATIONAL THERAPIST IN HEALTH & FAMILY WELFARE DEPARTMENT UNDER POST CODE 02/2014

 The Delhi Subordinate Services Selection Board (DSSSB), on the requisition of Health & Family Welfare Department, GNCTD, had issued advertisement on 21.01.2014 with closing date 27.2.2014 inviting applications for filling vacancies in the post of Occupational Therapist/ Recreational Therapist under the post Code 02/2014 vide Advertisement No. 01/2014 whereby 12 vacancies (09-OBC, 3 SC including 01-PH) advertised.

 Sh. Parvesh Gautam (DOB: 01.02.1982) applied for the post of Occupational Therapist/ Recreational Therapist under Post Code 02/114 under SC Category and was assigned Roll No. 12000120.

 The result for the post code was declared by DSSSB vide Result Notice No. 319 dated 18.05.2015 and he secured 73 marks. Sh. Parvesh Gautam was kept as Waitlist-01 SC candidate.

4. Sh. Parvesh Gautam challenged the Result Notice No. 319 dated 18.05.2015 before the Ld. Tribunal seeking quashing and setting aside the result notice no. 319 dated 18.05.2015 of recruitment of Ms. Sheela Gautam as Occupational Therapist in SC Category as per the post requirement of H&FW Department, which is in violation to the Delhi Council for Physiotherapy and Occupational Therapy Act. No. 7 of 1997 and rules framed there under by the Delhi Council of Physiotherapy and Occupational Therapy, thereby declaring him as a successful candidate to the post of Occupational Therapist against the post allotted to Ms. Sheela Gautam as she did not fulfill the criteria as per the RR's.

5. The Hon'ble Tribunal vide Order dated 27.11.2024 disposed of the O.A. No. 2368/2016 with following observations/directions:-

"20. Given the above, offer of appointment should rightly have gone to the applicant instead of respondent no.4. However even R-4 is not at fault since no relevant information has been concealed by her for taking the appointment. Hence this is a fit case where respondents, who are at fault for not being circumspect and meticulous earlier while processing the case of appointment; and are now morally and legally bound to make amends and ensure that there is no further miscarriage of justice. In our considered opinion

ends of justice would be met if respondents are directed to issue an offer of appointment to the applicant, of course after due verification and on completing other formalities. The said appointment will be against any other sanctioned vacant post, in case a vacant post is not available then a supernumerary post be created temporarily to adjust the applicant till a vacancy arises.

- 21. We are not issuing any directions to the detriment of R-4, since we have already held that R-4 is not at fault.
- 22. OA is disposed of accordingly. No order as to costs.
- 6. Against above order dated 27.11.2024 of Hon'ble CAT, a writ Petition was filed in Hon'ble High Court of Delhi vide No. W.P.(C) No. 5648/2025. But the same was dismissed by the Hon'ble High Court vide Order dated 16.05.2025. The Department of Law, Justice & Legislative Affairs, Govt. of NCT of Delhi opined that there does not seem to be any infirmity in the Order dated 16.05.2025 passed by Hon'ble High Court of Delhi and filing an SLP is not a prudent course of action.
- 7. Accordingly, in compliance with the Order dated 27.11.2024 of Hon'ble Tribunal in O.A. No. 2368/2016, upheld by the Hon'ble Delhi High Court vide Order dated 16.05.2025 in W.P.(C) No. 5648/2025 and the Legal Opinion of the Law Department, GNCTD, Sh. Parvesh Gautam (DOB: 01.02.1982, Roll No. 12000120) is hereby provisionally nominated, under SC Category, for the post of Occupational Therapist/Recreational Therapist under the post Code 02/2014 in Health & Family Welfare Department, GNCTD, subject to fulfilling all others conditions of eligibility and also correctness of information furnished by the candidate in his application form and dossier.
- 8. As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, no scrutiny of documents in the dossier and of the other terms and conditions of recruitment notified by the Board in the advertisement of the said post code has been done by the Board. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advt. No. 01/2014 & its corrigendum/ addendum etc. (if any) and relaxation as per rules in respect of educational qualifications, experience, other certificates shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the Post Code 02/2014 before issuance of offer of appointment of the post.
- 9. The provisional nomination of the above 01 candidate (SC-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the

candidate.

- 10. The provisional nomination of the above 01 candidate (SC-01) shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of his identity with reference to his photograph, signature/ handwriting, etc. on the application form, admission certificate, etc. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about her eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 11. The User Department i.e. Health & Family Welfare Department, GNCTD shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to take decision to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 12. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of caste certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 13. The User Department shall also get the SC/ST/OBC/EWS certificates verified from the issuing authority before her appointment. Further, in case of OBC Candidate, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No.

36033/3/ 2004-Estt. (Res) dated 09/03/2004 and OM No.36033/3/2004-Estt.(Res) dated 14/10/2008 OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017 OM No. 36039/1/2019-Estt. (Res) dated 31/01/2019.

- 14. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his eligibility as laid down in the recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 15. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 16. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 17. The recruitment process for the Post of Occupational Therapist/ Recreational Therapist under the post Code 02/2014 in Health & Family Welfare Department, GNCTD has already been closed. Further, the Wait List panel of the candidates has already been expired on 17.05.2016.
- 18. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 19. The nomination of the candidate is subject to outcome of review petition filed in the matter, if any. Further, the User Department shall also ensure that subsequent appointment and any other action will be subject to outcome of review petition filed in the matter at any stage.
