SUPPLEMENTARY RESULT NOTICE NO. 1560 GRADE-IV (DASS) IN SERVICES DEPARTMENT POST CODE 61/2015

- The DSSSB vide its advertisement No. 01/2015 with closing date 26.11.2015 and addendum dated 15.09.2017 and 07.06.2018, had advertised 1269 vacancies (UR-650, OBC-188, SC-200, ST-231 including OH-10, HH-32, VH-21, EX-173 and SP-79) for the Post of Grade-IV (DASS) in Services Department under post code 61/2015.
- 2. Sh. Sumit (Roll No. 15400301) applied for the post of Grade-IV (DASS), under Post Code 61/2015 in Services Department and appeared in Written exam on 17.09.2017, which he passed and was shortlisted to appear for typewriting skill test along with other shortlisted candidates. The skill test was qualifying in nature. His details are as under:-

- 3. Without applying for exemption from appearing in Typing/Skill Test, Sh. Sumit participated in the typing/skill test on 03.01.2018, where he gave his skill test in English. However, he failed to qualify the same, as his typing speed was 33.46 w.p.m. which was below 35 w.p.m. in English as per the Recruitment Rules.
- Sh. Sumit (Roll No. 15400301) filed O.A No. 3188/2018 titled as Sumit Vs GNCTD & Ors. The Ld. Tribunal allowed the O.A. vide order dated 17.05.2024 with following directions:-

Page 1 of 6

"15. Since the applicant chose to participate in the typing test without seeking exemption and failed. We direct that the applicant shall not be entitled to any consequential relief except notional seniority.

XXX

- 16. In view of the above, the applicant is entitled to the grant of exemption towards the typing test, the OA deemed to be allowed. The actual benefits to the applicant shall be accorded from the date of the joining. This exercise shall be done within a period of two months from the date of receipt of a copy of this order.
- 17. The present OA is allowed. No order as to costs."
- 5. The Writ Petition filed by DSSSB has also been dismissed by the Hon'ble Delhi High Court vide Order dated 20.02.2025 in W.P.(C) No.2238/2025 with following directions: -
 - "32. Thus viewed, given the fact that the respondent was, undisputedly, a candidate suffering over 60% orthopaedic disability in his elbow, we are of the opinion that the Court has, in such circumstances, to step in and ensure that the benefit of exemption from the typewriting test, available to such candidates, is available to the respondent, and that the mere fact that the respondent did not have, with him, his disability certificate at the time of undertaking the typewriting test cannot be a ground to disentitle him to the accommodation otherwise provided to candidates suffering from the said disability.
 - 33. The impugned judgment of the Tribunal harmonizes with the guiding philosophy behind grant of reasonable accommodation to persons with disability.
 - 34. In that view of the matter, we do not find this to be a case in which, an exercise of our jurisdiction under Article 226 of the Constitution of India, we should interfere with the judgment of the Tribunal.
 - 35. Needless to say, as is apparent from the above recitation, we are passing this judgment in the peculiar circumstances of this case, especially keeping the fact that the respondent had in fact expressed disability in undertaking the typing test during the time when he was undertaking it and sought exemption, and had been issued a disability certificate prior thereto. We would not want this judgement to be treated as a carte blanche to do away with all procedural requirements which apply in such cases. Ultimately, in each case, the Court has to approach the matter keeping in mind the facts before it.

36. The writ petition is accordingly dismissed."

- 6. Accordingly, in compliance with the Order dated 17.05.2024 of Hon'ble Tribunal in O.A No. 3188/2018, upheld by the Hon'ble Delhi High Court vide Order dated 20.02.2025 in W.P.(C) No. 2238/2025 and as per the Legal Opinion of Law Department & the Standing Counsel, GNCTD, the candidate Sh. Sumit (Roll No. 15400301) was provisionally shortlisted for up-loading of e-dossier in post code 61/2015-Grade-IV (DASS) in Services Department, by granting exemption from appearing in Skill/Typing Test vide Notice No. 1553 dated 06.08.2025, subject to the correctness of the information furnished by him in his online application form. The e-dossier link was active from 12/08/2025 to 26/08/2025. The candidate has uploaded his e-dossier within the above time period.
- 7. In view of this, Sh. Sumit (DOB: 11.04.1994, Roll No. 15400301) is hereby provisionally nominated, under PH(OH) Category, for the post of Grade-IV (DASS)/LDC under the post Code 61/2015 in Services Department, GNCTD, subject to fulfilling all others conditions of eligibility and also correctness of information furnished by the candidate in his application form and e-dossier.
- 8. As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, no scrutiny of documents in the dossier and of the other terms and conditions of recruitment notified by the Board in the advertisement of the said post code has been done by the Board. The eligibility as per Recruitment Rules and other terms and conditions as specified in the Advt. No. 01/2015 & its corrigendum/addendum etc. (if any) and relaxation as per rules in respect of educational qualifications, experience, other certificates shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the Post Code 61/2015 before issuance of offer of appointment of the post.
 - The provisional nomination of the above 01 candidate (PH/OH-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
 - 10. The provisional nomination of the above 01 candidate (PH/OH-01) shall further be subject to genuineness of the documents on the basis of which he has claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the



advertisement inviting application and subject to thorough verification of his identity with reference to his photograph, signature/handwriting, etc. on the application form, admission certificate, etc. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about her eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

- 11. The User Department i.e. Services Department, GNCTD shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the edossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to take decision to rectify/ correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 12. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of caste certificate as specified Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 13. The User Department shall also get the SC/ST/OBC/EWS certificates verified from the issuing authority before her appointment. Further, in case of OBC Candidate, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/ 2004-Estt. (Res) dated 09/03/2004 and OM No.36033/3/2004-Estt.(Res) dated 14/10/2008 OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017 OM No. 36039/1/2019-Estt. (Res) dated 31/01/2019.

- 14. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after being satisfied about his eligibility as laid down in the recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 15. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 16. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 17. The recruitment process for the Post of Grade-IV(DASS) under the post Code 61/2015 in Services Department, GNCTD has already been closed. Further, the Wait List panel of the candidates was valid upto 15.07.2019.
- 18. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 19. The nomination of the candidate is subject to outcome of review petition filed in the matter, if any. Further, the User Department shall also ensure that subsequent appointment and any other action will be subject to outcome of review petition filed in the matter at any stage.
