And, whereas upon verification of one of aadhar card No. - 225186650727 from website of UIDAI revealed that said aadhar card number No. - 225186650727 belongs to age band 50-60 years which confirmed that above candidate No. 2 is using fabricated aadhar card and impostured to help the candidate No. 1, as there are very rare chances that two different persons in a village may have same name, same date of birth, same father's name, same mother's name, address, same qualification and same marks from same university. Thus, it is a clear cut case of impersonation noticed by authorities of DSSSB and Overall Incharge of the examination centre. The Overall Incharge of the examination centre filed FIR No. - 0336 / 2025, date and time of FIR-16.09.2025, 01:44 A.M. at Police Station, Sector-58, Noida, Uttar Pradesh Police, Uttar Pradesh - 201309.

And, whereas it is not out of place to mention here that the candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned that stern action will be taken against candidates found guilty of misconduct.

And, whereas in terms of clause No. 11 regarding "Action against candidates found guilty of misconduct" as published in Advertisement No. 09 / 2024 dated 27.12.2024 issued

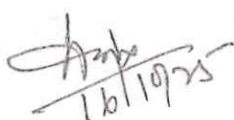
by this Board regarding recruitment to the post of Librarian, District & Session Courts, Post Code 823/24 states that :-

*Candidates are warned that they should not furnish any particulars that are false or suppress any material information while filling in the application form.*

*Without prejudice to criminal action/debarment from DSSSB's examination wherever necessary, candidature will be summarily cancelled at any stage of the recruitment in respect of candidates found to have indulged in any of the following:*

- (i) Possession of mobile phone & accessories and other electronic gadgets within the premises of the examination centre, whether in use or in switch off or switch on mode.*
- (ii) Involved in malpractices.*
  - a. Using unfair means in the examination hall.*
  - b. Obtaining support for his / her candidature by any means.*
  - c. Impersonate/Procuring impersonation by any person.*
  - d. Submitting fabricated documents or documents which have been tampered with.*
  - e. Making statements which are incorrect or false or suppressing material information.*
  - f. Resorting to any other irregular or improper means in connection with his/her candidature for the examination.*
  - g. Misbehaving in any other manner in the examination hall with the Supervisor, Invigilator or Board's representatives.*
  - h. Taking away the Answer Sheet (in case of offline/online/descriptive/skill test papers) with him/her from the examination hall, or passing it on to unauthorized persons during the conduct of the examination.*
  - i. Intimidating or causing bodily harm to the staff employed by the Board for the conduct of examination.*
  - j. Not fulfilling the eligibility conditions mentioned in the Notice.*
  - k. Candidature can also be cancelled at any stage of the recruitment for any other ground which the Board considers to be sufficient cause for cancellation of candidature.*
  - l. If any candidate uses offensive/abusive/foul language /obscene picture he/she will be liable for necessary penal action under relevant Act.*

*In such cases, if required, the Board may also report the matter to Police/ Investigating Agencies, as deemed fit and the Board may also take*

And, whereas in view of above facts and circumstances, the DSSSB has come to the conclusion that, *prima facie*, a case of misconduct on attracting above clause 11 of Advertisement No. 09 / 2024 dated 27.12.2024 issued by this Board by *using unfair means in the examination hall, obtaining support for his / her candidature by any means, impersonate/procuring impersonation by any person & submitting fabricated documents or documents which have been tampered with etc.* is made out against the said candidates.
