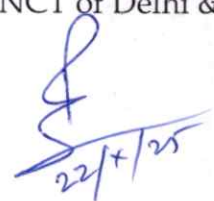
In compliance of order dated 13.11.2024 passed by Ld. CAT in O.A. No. 128/2019 in the matter of Ms. Ruchi Vs. Govt. of NCT of Delhi & ORS. and order dated. 10.09.2025 passed by Hon'ble High Court of Delhi in WP (C) No. 13876/2025 & CM Appeal 56858/2025 in the matter of Govt. of NCT of Delhi and Ors Vs Ruchi with regard to the post of Laboratory Technician(Group-III) under post code 34/14 in Health & Family Welfare Deptt, GNCT of Delhi, the following one candidate is provisionally nominated as under:-

It is submitted that the above candidate was earlier selected and appointed to the post of **Lab Assistant (Grade-IV)** under **Post Code 30/14** in the pay scale of Rs. 5200-20200 + Grade Pay Rs. 2400/- vide **Result Notice No. 492 dated 22.06.2016**, and she had joined the **Department of Health & Family Welfare, GNCTD**.

In compliance with the aforesaid orders of the **Ld. CAT** and the **Hon'ble High Court**, the provisionally nomination of the above 01 (One) candidate (UR-01) has been processed purely on the basis of marks obtained by the candidate in the combined examination conducted on 26.04.2015, and also claims made by the candidate in her offline application forms for the post under the Post code 34/14 in Health & Family Welfare, GNCT of Delhi. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement No. 01/2014 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 34/14 as on cut-off date 27.02.2014 before issuance of offer of appointment to the post and in accordance compliance of the order dated 26.07.2024 passed by Ld. CAT of Delhi in OA No. 128/2019 and Hon'ble High Court of Delhi in WP (C) No. 13876/2025 & CM Appeal 56858/2025 in the matter of Ruchi Versus Govt. of NCT of Delhi & ORS.

The User department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the User Department shall arrange to verify the correctness of the information/ documents as furnished in the dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally nominated candidate. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

As per the Board's resolution dated 14/07/2022 and as per decision of the Board dated 20/01/2023, the Board has not undertaken scrutiny of documents uploaded in the e-dossiers module and other terms and conditions of recruitment notified by the Board in the advertisement of the said post code at this stage. The eligibility as per Recruitment Rules and other terms and conditions as specified in the advertisement no. 01/2014 and relaxations as per rules in respect of educational qualifications, experience, etc. shall be scrutinized/verified by the User Department for determining eligibility of the candidate for the post code 34/14 as on cut-off date 27.02.2014 before issuance of offer of appointment to the post.

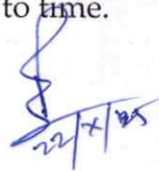
The category wise marks scored by the last provisionally nominated candidate after this supplementary result is as under:-

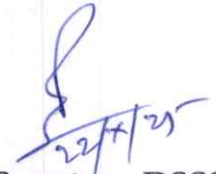
