ORDER

WHEREAS, The Hon'ble Central Administrative Tribunal, Principal Bench, New Delhi, vide order dated 06.11.2025 in OA No. 4033/2025 titled *Sonu vs. Govt. of Delhi & Ors.*, has directed as under:-

"A copy of the speaking order so passed shall be provided to the applicant. It is made clear that if the order is passed in favour of the applicant, consequential relief, if any, shall also follow within thirty days (30) days thereafter.

The OA is disposed of in the aforesaid terms at the admission stage itself, without going into the merits. Pending MAs, if any, also stand disposed of. No order as to costs."

WHEREAS, As per requisition received from the Department of Training & Technical Education (DTTE), GNCTD, the DSSSB vide its Advertisement No. 01/2014 had advertised posts of Craft Instructor (Computer Hardware and Networking) under Post code 123/14. The Vacancies position is as under:-

AND WHEREAS, The examination for Post Code 123/14 was conducted on **13.07.2019**. The marks of all candidates were uploaded on the Board's website vide Notice No. 819 dated 18.09.2019. The main result was declared vide Result Notice No.1205, dated 20.10.2020.

AND WHEREAS, The applicant, **Sh. Sonu (Roll No.3030000693)**, applied under the **OBC** category for the post of Craft Instructor (Computer Hardware and Networking under post code 123/14, appeared in the examination, and secured his **78.25 marks**. He was shortlisted for uploading of e-dossiers vide Result Notice No.1205 dated 20.10.2020.

AND WHEREAS, The marks of the last nominated candidate in post code 123/14 in OBC Category were 80.00 and the marks obtained by the applicant were as under: -

AND WHEREAS, The marks of Sh. Sonu were less than the marks of last shortlisted candidate, he was not shortlisted for the post in post code 123/14.

AND WHEREAS, Out of total 14 vacancies under Post code-123/14, 04 vacancies were for OBC candidates and all vacancies in OBC category were filled. The marks of last shortlisted candidate vide Result Notice No. 1348 dated 09.09.2021 in post code 123/14 in OBC Category were 84.50 and supplementary result notice No.1488 dated 10.10.2022 in OBC category was 80.00.

NOW THEREFORE, The candidature of Sh. Sonu (DOB: 07.04.1984) cannot be considered for the Post of Craft Instructor (Computer Hardware and Networking in post code 123/14, No additional dossiers were received from the user department during the validity of the waiting panel. The waiting panel has already been exhausted i.e. 19.10.2021. The entire result process now stands closed.

This issues with the prior approval of the Competent Authority and in compliance with the directions of Hon'ble C.A.T. vide Order dated 06.11.2025 in OA No. No. 4033/2025.
