ORDER

In compliance of the direction of Hon'ble Central Administrative Tribunal (CAT) Order dated 25.10.2024 in OA 2902/2017 (Pushpa Vs Govt of NCT & Ors), this order shall dispose off the request and claim of Ms Pushpa for consideration for the appointment to the post of TGT (Hindi)- Female under post code 07/13.

The Ld CAT has directed, vide Order dated 25.10.2024 in OA 2902/2017 (Pushpa Vs Govt of NCT & Ors).

17. In this view of the matter, the present OA is also partly allowed with a direction to the respondents to consider the candidate of the applicant for the relevant post-code(S), subject to her being found in merit and otherwise suitable at the relevant point of time. If the applicant is found eligible she should be appointed to the relevant post. On such appointment, the applicant shall be eligible for consequential benefits, such as seniority, and fixation of pay from the date when her immediate junior in the relevant merit list has been appointed. However, the fixation of pay shall be on a notional basis and the applicant shall not be entitled to any arrears.

Ms Pushpa had submitted application for appointment to the post of TGT Hindi Female under Post Code 07/13 through OMR-based application forms as per DSSSB Advertisement No. 01/2013. During scrutiny of her application Form, it was observed that she had not correctly bubbled the mandatory fields relating to Essential Educational qualifications. On this grounds, her application Form against post code 07/13 was rejected.

Ms Pushpa approached Hon'ble CAT by filling OA No. 2902/2017 for seeking appropriate directions to the respondents to consider her case for appointment. The Hon'ble CAT pronounced its final decision vide order dated 25.10.2024 in OA No. 2902/2017 (Pushpa v/s GNCTD & Ors) and allowed the OA with above stated directions.

As per para 17 of the Ld CAT order dated 25.10.2024 in OA 2902/2017, Ld CAT has directed "to consider the applicant for relevant post code, **subject to her fulfilling eligibility and merit conditions at the relevant point of time. If found eligible, she shall be appointed with consequential benefits....**"

The point of eligibility criteria related to Central Teacher Eligibility Test (CTET) could not be presented properly as the whole OA was based on non-bubbling of eligibility criteria related to Degree/Diploma in Teaching SAV Certificate.

However, after receipt of this order, DSSSB checked eligibility criteria of Ms Pushpa as per the directions in order dated 25.10.2024. It has been found that she has enclosed Central Teacher Eligibility Test (CTET) Certificate dated 26.11.2011 (Annexure A-10 of OA 2902/ 2017). On the basis of this CTET certificate, it is found that she is not qualified in Central Teacher Eligibility Test (CTET) applicable for TGT Hindi post at the relevant point of time i.e. cut-off date for the post code 07/13. Although she did not bubble the column related to Degree/Diploma in Teaching SAV Certificate; but simultaneously, she wrongly bubbled the column related to CTET Qualification in the OMR based application form and declared herself as eligible/qualified for TGT Hindi post, whereas she is not eligible for the post of TGT Hindi.

On scrutiny of this Certificate, it is clear that she has not fulfilled one essential eligibility criteria required for applying / selection / appointment to the post of TGT Hindi. Vide para 6 of above referred order dated 25.10.2024 of Ld Tribunal, it is clear that she (the applicant) was declared qualified only for classes 1 to 5. This is wrongly considered as qualified in CTET for TGT Hindi also. It is pertinent to mention that for consideration/appointment to the post of TGT Hindi, she needed to qualify in Paper II of CTET, which are meant for class VI to VIII. Declaring herself as CTET Qualified on the basis of CTET certificate dated 26.11.2011 (Annexure A-10 of OA 2902/2017, is totally misleading fact advanced by the applicant in the present matter.

Along with OMR based application form of post code 07/13, documentary proofs regarding fulfilment of essential educational qualification and other conditions were not sought, thus not submitted by the applicant. Therefore, factual position of CTET related conditions could not be verified during earlier stages.

Now, at this stage, it is found that the applicant Ms. Pushpa is actually not having essential qualification required to apply for the post of TGT Hindi in as much as she is not qualified in paper II of CTET.

In view of the above, it is decided that Ms Pushpa is not eligible for appointment to the post of TGT Hindi female against post code 07/13. Therefore, in compliance of above stated Ld CAT order, the matter of considering the candidature of the applicant Ms Pushpa for the post code 07/13 is hereby disposed off by rejecting her candidature.

This issues with the approval of Chairman DSSSB.
