## ORDER

Whereas the Board vide its advertisement No.03/21 had advertised total-866 vacancies (EWS-25, UR-390, OBC-275, SC-115, ST-61 including PwD: OH-19, VH-16) for the Post of TGT (Sanskrit) Male under post code 54/21 in Directorate of Education and conducted Tier-I examination (online mode) for recruitment on 05.09.2021

And whereas, Sh. Raja Ram Meena (Roll No. 111505400160), candidate for the post of TGT (Sanskrit) Male under post code 54/21 in Directorate of Education had applied under ST category through OARS application form and appeared in the online written examination held on 05.09.2021 & scored 80.39 marks in written examination.

And whereas on the performance in the written examination, the qualified candidates who obtained marks above or equal to minimum qualify marks in their respective category were shortlisted for uploading of e-dossier subject to attaining the minimum qualifying marks and correctness of the information furnished by the candidate in their online application forms. The cutoff marks for uploading of e-dossier was marks, UR-82.41, OBC-78.90, SC-80.88, ST-62.81 & PH-OH-64.85, PH-VH-88.83 marks.

And whereas the candidature of Sh. Raja Ram Meena (Roll No. 111505400160), could not come under UR category for being lower in merit but as he had applied under ST category, he was shortlisted under ST category for uploading of e-dossier. Accordingly, he was directed to upload requisite document as per RR w.e.f. 21/12/2021 to 04/01/2022 vide notice dated 15/12/2021.

And whereas the candidate, Sh. Raja Ram Meena has uploaded the requisite documents in E-dossier within stipulated time and after preliminary scrutiny of documents and as per his merit under ST category he was placed under waiting list of ST category vide Main Result Notice No. 874 dated 20.06.2022( read with corrigendum dated 15.09.2022).

And whereas it was later on revealed after receiving of the applicant representation dated 29.07.2022 as well as court case filed by him wherein he stated that he actually belongs to PH category candidate and he should be considered for nomination under PH category as he has secured more marks than last nominated candidate under PH Category. Further, he reiterated in his representation that he availed the extra time of 40 minutes at the examination center after showing disability certificate.

And whereas the candidate's log details was sought from Edcil and as per log details it was revealed that he has availed extra time of 40 minutes for which he was not entitled as he belongs to ST category only as per his OARS application form and as per Para -6.ii of the advertisement it was clearly stated that "The candidate has to select that particular category when applying online for the post. No request for change of category will be entertained at any later stage." Further, there is no available document (undertaking/declaration) as

claimed by the applicant to ascertain his PH category status at the exam center and how he got extra time in the exam.

And whereas he also gave a declaration in his own handwriting in English on page 2 of Photo attendance sheet that "I certify that I am the person whose name Roll No. and Photograph appear above on this e-admit card. I hereby declare that the information given in this application is true and correct to the best of my knowledge and belief. In case any information given in this application proves to be false or incorrect, I shall be responsible for the consequences".

And whereas since it has now been established that the candidate Sh. Raja Ram Meena (Roll No. 111505400160) wrongly availed the extra time of 40 minute without opting PwD category and he belongs to ST category only as per OARS application form and hence, he is not entitled to avail extra time.

Therefore, in view of above, the candidature of the candidate Sh. Raja Ram Meena (Roll No. 111505400160) under waiting panel list of ST category vide main result notice 874 dated 20.06.2022 (read with corrigendum dated 15.09.2022) shall stands cancelled in all respect by rescinding the result notice no. 874 in respect of Sh. Raja Ram Meena under ST Category.

Therefore, the candidature of Sh. Raja Ram Meena (Roll No.111505400160) is rejected in all respect for the post of TGT (Sanskrit) Male Post code 54/21 in Directorate of Education.
