**ORDER**

**SUB: Compliance of order/direction dated 24.02.2023 of the Hon'ble CAT as passed in OA No. 452/2023 titled as Kuldeep Singh Versus GNCTD & Anr.**

WHEREAS, the Hon'ble CAT of Delhi vide its order dated 24.02.2023 passed in OA No. 452/2023, titled as Kuldeep Singh Versus GNCTD & Anr., has directed as under:

*"5. ---- In view of above and without going into the merits of the case, the O.A. is disposed of, at the admission stage itself, with a direction to respondents, particularly, respondent No.2, to decide and dispose of the pending representation of the applicant dated 08.08.2022 (Annexure A-8) by passing an appropriate reasoned and speaking order, as expeditiously as possible, in no case later than two months from the date of receipt of copy of this order.*

*6. The O.A. is disposed of in the above background no. order as to costs".*

As per court direction, the reasoned speaking order in pursuance of the above court order in Para no. 5 on the representation dated 08.08.2022 received from Sh. Kuldeep Singh, (Roll No. 16008728) is as under:

**The brief facts as per the details given below:**

1. WHEREAS, The DSSSB vide its advertisement No. 03/13 had advertised **Total- 99 vacancies** (UR- 50, OBC-27, SC-15 & ST-07 (Including ExSM-10) for the Post of Head Constable under Post Code- 43/13 in Transport Department, GNCTD. The cut-off date/closing date of application was 18.10.2013.
2. AND WHEREAS, on the basis of written examination conducted on 28.09.2014, the list of shortlisted candidates was declared vide Notice No. 418 dated 24.07.2015 for appearing in PET exam conducted on 15.06.2016 & 16.06.2016 at Chhatrasal Stadium.
4. AND WHEREAS, The result has been processed keeping in view of the eligibility conditions and relaxation thereof in respect of educational qualifications etc. as on cut-off date i.e. 18.10.2013 for the Post Code 43/13 and the **Result Notice No. 523 dated 01.08.2016 (Provisional Result) for the above post code issued by the DSSSB is withdrawn vide Public Notice No. 525 dated 23.08.2016 due to Administrative/Judicial reason in pursuance to CAT order dated 01.07.2016 in OA No. 2162/2015, MA No. 2027/2016.**



5. AND WHEREAS, in continuation of Result Notice No. 608 dated 31.01.2018, Result Notice No. 661 dated 01.06.2018, Result Notice No. 692 dated 23.07.2018, Result Notice No. 745 dated 10.01.2019, Result Notice No. 808 dated 09.09.2019, Result Notice No. 869 dated 03.12.2019, Result Notice No. 1109 dated 17.07.2020 have been issued and as of now there is no vacancy available with DSSSB. The recruitment process has already been closed and waiting panel has expired on 30.01.2019.
6. AND WHEREAS, the petitioner Sh. Kuldeep Singh in OBC category allotted Roll no. 16008728 had obtained 153.75 marks and the last waiting panel candidate (OBC-WL-06) had obtained **157.75** marks. Therefore, Sh. Kuldeep Singh in OBC category was not found admissible due to below merit in OBC category.

**NOW, THEREFORE,** In view of above, the claim of the petitioner, Sh. Kuldeep Singh, Roll no. 16008728 for the Post of Head Constable under Post Code- 43/13 in Transport Department, GNCT of Delhi has been examined, considered and not found admissible in view of the facts mentioned above, hence may be rejected.
