# SUPPLEMENTARY RESULT NOTICE NO. 886 DATED 28/07/2022

# ASSISTANT TEACHER (NURSERY), POST CODE 43/21 IN DIRECTORATE OF EDUCATION

The DSSSB vide advertisement No. 02/2021 dated 12.05.2021 had advertised 74 vacancies (UR-52, EWS-02, OBC-08, SC-09, ST-03, including PwD – (OH-03, VH-03, MD-02) for the post of Assistant Teacher (Nursery) Post Code 43/21 in Directorate of Education. However, vide corrigendum to the post code 43/21 dated 19.07.2021, the vacancies of the aforesaid post code had been revised as 74 (UR-46, EWS-08, OBC-08, SC-09, ST-03 including PwD (OH-01, VH-01, HH-01, MD-01).

- 2. Online written examination for the post of Assistant Teacher (Nursery) Post Code- 43/21 was held on 21st, 23rd & 24th October, 2021.
- 3. On the basis of written examination held on 21st, 23rd & 24th October, 2021 and after preliminary scrutiny as per the provisions of the statutory Recruitment Rules for the post of **Assistant Teacher (Nursery), Post code- 43/21** and the terms and condition of the advertisement No. 02/2021, a total of 70 (UR-46 including PH/HH-01, PH/MD-01, EWS-04, OBC-08, SC-09 including PH/VH-01, PH/OH-01, ST-03) candidates were provisionally nominated as per their merit vide Main Result Notice No. 877 dated 24.06.2022. Thereafter lowering the merit of EWS Category 13 more candidates were shortlisted for filing of E-dossier and notice was sent on 29.06.2022 to fill the E-Dossier during the period 08.07.2022 to 22.07.2022. After the stipulated time only 08 candidates filled their E-dossier online. Among them as per their merit 04 candidates are hereby provisionally selected against 04 vacant posts of EWS category by issuing the supplementary Result.
- 4. As per resolution of the Board meeting held on 06/07/2022 and communicated Vide U.O .No. 7(04)/16/P&P/DSSSB/Part-I/1036 dated 14.07.2022, the board will process and declare the results on the basis of marks of the shortlisted candidates without scrutiny of the documents of E-Dossier at the level of result processing Branch and no first recall or Second Recall are to be given.
- 5. The Board will reject the candidature of shortlisted candidates only in case if he/she failed to upload his/her E-dossier within the stipulated time of 15 days. No rejection to be done on the basis of scrutiny of E-dossier.
- 6. Now the DSSSB is preparing the result as per the resolution decision taken by Board by only selecting the E-Dossiers filled by the candidates and those are prepared for sending to user department without scrutiny.

- 7. The result has been processed purely on the basis of marks obtained by the candidates in the examination held on 21st, 23rd & 24th October, 2021 and also claims made by the candidates in their online application forms of the post code 43/21 for the post of Assistant Teacher (Nursery) in Directorate of Education. The merit list is prepared based on total marks obtained as well as marks obtained in Part-A and Part-B( of those candidates who obtained more than qualifying marks in both part A and part B separately). The Board has not undertaken scrutiny of documents uploaded in the E-dossiers at this stage, as per Board's resolution/decision dated 14.07.2022. The eligibility as per Recruitment Rules and other terms conditions as specified in the advertisement number 02/21 relaxations as per rules in respect of educational qualifications, age experience, etc., shall be scrutinized/verified by the user Department for determining eligibility of the candidates for the post code 43/21 as on cut off date 24.06.2021 before issuance of offer of appointment to the post.
- 8. On the basis of marks secured in the written examination and considering other relaxations, if any, claimed by the candidates in their online application forms, the candidates having followings Roll Nos. are hereby provisionally nominated for the post Assistant Teacher (Nursery) under Post Code 43/21 in Directorate of Education, GNCTD, subject to fulfillment of all other conditions of eligibility and also correctness of the information furnished by the candidates in their online applications forms and E-dossier:-

- 9. The selection of the above **04 (EWS-04)** shall be subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 10. The selection of the above **04** (EWS-04) candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- 11. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste

Certificates furnished by the candidate prior to issuing offer of appointment to the candidate. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

- 12. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 13. The User Department shall also get the SC/ST/OBC/PH/ExSM/ etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.
- 14. Further, in case of EWS candidates, it may also be verified that the validity of EWS certificate should be as per DOPT OM No. 36039/1/2019-ESTT (Res) dated 31.01.2019 and other instructions/guidelines issued from time to time in this regard by the competent authorities.
- 15. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

- 16. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.
- 17. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.

19. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage or arising due to court cases., if any.

#### WAITING PANEL LIST

- 20. Further, in accordance with the Service Department Circular No. F.16 (3)/DSSSB/2007-S-III/1268 dated 13.06.2019, the Board prepares and maintains waiting panel /reserve panel and all the candidates above minimum qualifying marks in their respective categories are kept in waiting /reserve panel subject to call of e-dossier/verification of documents. The waiting panel is valid for a period of one year from the date of declaration of main result for filling up the vacancies arising due to non-acceptance of the offer of appointment, not joining the post after acceptance of appointment, resignation after joining, etc. within one year of validity of panel.
- 21. Now, in accordance with Services Department Circular No. F.16 (3)/DSSSB/2007-S-III/1756-1763 dated 02/08/2021, the Board has decided that out of the waiting /reserve panel comprising all the candidates above minimum qualifying marks, the Board will also notify and nominate candidates to the extent of 20% of the notified vacancies as waitlisted candidates in order of merit after scrutiny of their e-dossier and share it with the User Department with a request to utilize the same in accordance with the services department Circular No. F.16(3)/DSSSB/2007/S-III.1268 dated 13.06.2019 and inconformity with DoPT guidelines and instructions of Govt. of NCT of Delhi issued from time to time and also mentioned from clause 1 to 19 of this result notice. Accordingly, following candidates in EWS Category are hereby nominated as waitlisted candidates:-

- 23. The User Department, being Cadre Controlling /Appointing Authority, shall strictly follow the merit based ranking of the candidate in the main list and the waiting list.
- 24. The User Department, at its own level, will utilize the Waiting list only after exhausting he main list and after affording sufficient opportunity to the provisionally nominated candidates as per the extant guidelines issued by the GNCTD/DoPT.
- 25. The candidates in the Waiting Panel or the Balance Reserve panel shall have no claim or right for appointment per se against the vacancies notified for the recruitment. They can only get the offer of appointment only in the event any vacancies (category-wise) arising due to non-acceptance of the offer of appointment, not joining the post after acceptance of appointment, resignation after joining, etc within one year of validity of panel.
- 26. While operating the waiting panel list, the User Department shall strictly follow instructions issued vide DoPT OM No. 36012/2/96-Estt. (Res.) dated 02/07/1997, 36011/1/98-estt. (Res.) dated 01/07/1998 and 43011/4/2018-Estt. (Res.) dated 04/04/2018 regarding shifting of candidates from respective reserve categories to the un-reserve category.
- 27. The User department shall operating the waiting panel upto the number of vacancies notified under each category by the DSSSB in its advertising and not beyond it even by taking any type of relaxation from any authority as it shall rendered the excess appointment void and illegal Ab initio.
- 28. As soon as validity period of the waiting panel expires and / or number of notified vacancies are filled up hence waiting panel becomes redundant, the User Department shall return the cancelled and unutilized dossiers to DSSSB with complete details statistics forthwith.
- 29. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage or arising due to court cases., if any.
- 30. Wherever, the Court has directed to not declare result without leave of the court such cases will be dealt separately, if falling in main result/proposed 20% waiting panel list. The User Department shall decide such cases subject to outcome of court case(s).

- 31. The result is subject to the outcome of the court cases/FIR, if any, pending in various courts related to this post code.
- 32. The recruitment process for the post of Assistant Teacher (Nursery), Post Code-43/21 is hereby closed. Further, the Wait List panel of the candidates shall be valid upto 23.06.2023.
- 33. This issues with the prior approval of the Chairman, DSSSB.
